CONSENT AGREEMENT AND FINAL ORDER

I. Nature of the Action

- 1. This is a civil penalty proceeding pursuant to Section 14(a) of the Federal Insecticide,
 Fungicide, and Rodenticide Act, as amended, 7 U.S.C. § 136l(a) (FIFRA), and pursuant
 to the Consolidated Rules of Practice Governing Administrative Assessment of Civil
 Penalties and the Revocation/Termination or Suspension of Permits (Consolidated
 Rules), 40 C.F.R. Part 22. Complainant is the Director of the Air, Pesticides and Toxics
 Management Division, United States Environmental Protection Agency, Region 4 (EPA).
 Respondent is Active Research, LLC.
- 2. The authority to take action under Section 14(a) of FIFRA, 7 U.S.C. § 136*l*(a), is vested in the Administrator of the EPA. The Administrator of the EPA has delegated this authority under FIFRA to the EPA Region 4 by the EPA Delegation 5-14, dated May 11, 1994. The Regional Administrator, Region 4, has redelegated this authority to the Director, Air, Pesticides and Toxics Management Division, by the EPA Region 4 Delegation 5-14, dated September 7, 2005. Pursuant to that delegation, the Director of the Air, Pesticides and Toxics Management Division has the authority to commence an

enforcement action as the Complainant in this matter, and has the authority to sign consent agreements memorializing settlements between the EPA and Respondents.

3. Complainant and Respondent have conferred for the purpose of settlement pursuant to 40 C.F.R. § 22.18 and desire to resolve this matter and settle the allegations described herein without a formal hearing. Therefore, without the taking of any evidence or testimony, the making of any argument, or the adjudication of any issue in this matter, and in accordance with 40 C.F.R. § 22.13(b), this Consent Agreement and Final Order (CAFO) will simultaneously commence and conclude this matter.

II. Preliminary Statements

4. Pursuant to 40 C.F.R. § 22.5(c)(4) the following individual is authorized to receive service for the EPA in this proceeding:

- Respondent is Active Research, LLC, a limited liability company, located at 1226
 Highland Street, North, Saint Petersburg, Florida, 33701.
- 6. Respondent is a "person" as defined by Section 2(s) of FIFRA, 7 U.S.C. § 136(s), and as such is subject to FIFRA and the regulations promulgated thereunder.

III. Specific Allegations

 On or about July 20, 2009, an authorized representative of the EPA conducted an inspection at Respondent's facility located at 1226 Highland Street, North, Saint Petersburg, Florida 33701.

During the aforementioned inspection, Respondent provided an affidavit stating that 8. Respondent had "offered for sale" on the company's internet website, the product called Bed Bug Powder.

9. Prior to and at the time of the inspection, Respondent's website at www.bedbugpower.com included advertisements for Bed Bug Powder that stated that the product "kills bed bugs." This statement is considered to be making pesticidal claims for the product.

10. As a result of the pesticidal claims made for Bed Bug Powder, the product is a pesticide as defined in Section 2(u) of FIFRA, 7 U.S.C. § 136(u), which includes any substance or mixture of substances intended for preventing, destroying, repelling, or mitigating any pest.

11. A pest is defined in Section 2(t) of FIFRA, 7 U.S.C. §136(t), as any insect, rodent, nematode, fungus, weed, or any other form of terrestrial or aquatic plant or animal life or virus, bacteria, or other micro-organism (except viruses, bacteria, or other microorganisms on or in living man or other living animals) which the Administrator declares to be a pest under Section 25(c)(1) of FIFRA, 7 U.S.C. § 136w(c)(1).

12. At the time of the inspection, Respondent's business included distributing or selling pesticides. The term "to distribute or sell" as defined by Section 2(gg) of FIFRA, 7 U.S.C. § 136(gg), includes to distribute, sell, offer for sale, hold for distribution, hold for sale, hold for shipment, ship, deliver for shipment, or release for shipment.

Pesticides that are sold and distributed in the United States are required to be registered 13. with the EPA pursuant to section 3 of FIFRA.

- 14. At and prior to the time of the inspection, Bed Bug Powder was not registered as a pesticide with the EPA.
- 15. Under Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A), it is unlawful for any person to distribute or sell to any person any pesticide that is not registered under Section 3 of FIFRA.
- 16. Respondent violated Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A), on at least one occasion and is therefore subject to the assessment of civil penalties under Section 14 of FIFRA, 7 U.S.C. § 136l.
- 17. At the time of the inspection, Respondents website at www.bedbugpowder.com, had statements or representations which constitute misbranding as described in 40 C.F.R. 156.10(a)(5)(v). These statements includes "Bed Bug Powder is EPA Approved," and the EPA Seal (logo), implying that Bed Bug Powder is recommended or endorsed by the Federal Government.
- 18. Pursuant to FIFRA Section 2(q)(1)(A), 7 U.S.C. § 136(q)(1)(A), a pesticide is misbranded if its label is false or misleading in any particular.
- 19. Under Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E), it is unlawful for any person in any state to distribute or sell to any person any pesticide which is misbranded.
- 20. Respondent violated Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E), and is therefore subject to the assessment of civil penalties under Section 14 of FIFRA, 7 U.S.C. § 136l.
- 21. At the time of the inspection, Respondent was producing Bed Bug Powder in an establishment that was not registered with the Administrator of the EPA as a pesticide producing establishment. Section 7 of FIFRA requires that production of pesticides be

- conducted in a registered pesticide-producing establishment. "Production" includes formulation, packaging, repackaging, and relabeling.
- 22. Section 12(a)(2)(L) of FIFRA, 7 U.S.C. § 136j(a)(2)(L), makes it unlawful to produce a pesticide in any state unless the establishment is registered with the Administrator of the EPA as set forth in Section 7 of FIFRA, 7 U.S.C. § 136e.
- 23. Respondent violated Section 12(a)(2)(L) of FIFRA, 7 U.S.C. § 136j(a)(2)(L) and is therefore subject to the assessment of civil penalties under Section 14(a) of FIFRA, 7 U.S.C. § 136l(a).
- 24. Section 14(a) of FIFRA, 7 U.S.C. § 136*l*(a), in conjunction with the Debt Collection Improvement Act of 1996, authorizes the assessment of a civil penalty.
- 25. Section 14(a)(4) of FIFRA, 7 U.S.C. § 136*l*(a)(4), requires the EPA to consider the appropriateness of the assessed penalty to the size of business of the Respondent, the effect on Respondent's ability to continue in business, and the gravity of the violation.
- 26. After consideration of the factors set forth in Section 14(a)(4) of FIFRA, 7 U.S.C. § 136l(a)(4), the EPA proposes to assess a total civil penalty of FIVE THOUSAND

 THREE HUNDRED FIFTY-FIVE DOLLARS (\$5,355) against the Respondent for the above-described violations. Civil penalties under Section 14(a) of FIFRA, 7 U.S.C. § 136l(a), may be assessed by Administrative Order.

IV. Consent Agreement

- 27. For the purposes of this CAFO, Respondent admits the jurisdictional allegations set forth above and neither admits nor denies the factual allegations set forth above.
- 28. Respondent waives its right to a hearing on the allegations contained herein and its right to appeal the proposed Final Order accompanying the Consent Agreement.

- 29. Respondent consents to the assessment of the penalty proposed by the EPA and agrees to pay the civil penalty as set forth in this CAFO.
- 30. Respondent certifies that as of the date of its execution of this CAFO, it is in compliance with all relevant requirements of FIFRA.
- 31. Compliance with this CAFO shall resolve the allegations of the violations contained herein. This CAFO shall not otherwise affect any liability of Respondent to the United States. Other than as expressed herein, neither the EPA nor Complainant waives any right to bring an enforcement action against Respondent for violation of any federal or state statute, regulation or permit, to initiate an action for imminent and substantial endangerment, or to pursue criminal enforcement.
- 32. Complainant and Respondent agree to settle this matter by their execution of this CAFO.
 The parties agree that the settlement of this matter is in the public interest and that this
 CAFO is consistent with the applicable requirements of FIFRA.

V. Final Order

33. Respondent is assessed a civil penalty of **FIVE THOUSAND THREE HUNDRED FIFTY-FIVE DOLLARS (\$5,355)**. Four payments, including interest, will be made to complete payment of the entire civil penalty, in accordance with the schedule set forth below. The first payment shall be made by October 31, 2012, and the subsequent three payments shall be due in 90 day intervals thereafter. Including the civil penalty and interest, the total amount that will be paid upon the completion of all payments will be **FIVE THOUSAND THREE HUNDRED SEVENTY-FIVE DOLLARS** and **FORTY CENTS** (\$5,375.40). Respondent shall make payments in accordance with the following schedule:

34. Respondent shall remit each penalty payment by either a cashier's or certified check made payable to the "Treasurer, United States of America," and shall send the check via U.S. Mail to the following address:

The check shall reference on its face the name of the Respondent and Docket Number of this CAFO.

35. At the time of each payment, Respondent shall send a separate copy of the check and a written statement that the payment is being made in accordance with this CAFO, to the following persons at the following addresses:

- 36. If Respondent fails to make one of the installment payments in accordance with the schedule set forth above, and if such payment is not made within 30 days after the due date, that payment plus all subsequent payments (the entire unpaid balance) shall become immediately due and payable on the 31st day from such due date. In addition, Respondent shall be liable for and shall pay administrative handling charges and late payment penalty charges as described below in the event of any such failure or default.
- 37. Further, if Respondent fails to pay the installment payments in accordance with the schedule set forth above, the EPA may refer the debt to a collection agency, a credit reporting agency, or to the Department of Justice for filing of a collection action in the appropriate United States District Court. In any such collection action, the validity, amount, and appropriateness of the assessed penalty and of this CAFO shall not be subject to review.
- 38. Notwithstanding Respondent's agreement to pay the assessed civil penalty in accordance with the installment schedule set forth above, Respondent may pay the entire civil penalty of **FIVE THOUSAND THREE HUNDRED FIFTY-FIVE DOLLARS** (\$5,355) within 30 days of the effective date of this CAFO and, thereby, avoid the payment of interest pursuant to 40 C.F.R. § 13.11(a). In addition, Respondent may, at any time after commencement of payments under the installment schedule, elect to pay the entire principal balance remaining, together with interest accrued up to the date of such full payment.
- 39. Pursuant to 31 U.S.C. § 3717 and 40 C.F.R. § 13.11, EPA is entitled to assess interest and penalties on debts owed to the United States and a charge to cover the cost of processing and handling a delinquent claim. In accordance with 40 C.F.R. § 13.11(a), interest on any

civil penalty assessed in a CAFO begins to accrue on the date that a copy of the CAFO is mailed or hand-delivered to the Respondent. However, the EPA will not seek to recover interest on any amount of such civil penalty that is paid within 30 calendar days after the date on which such interest begins to accrue. Interest will be assessed at the rate of the United States Treasury tax and loan rate in accordance with 40 C.F.R. § 13.11(a). A

charge will also be assessed to cover the administrative costs, both direct and indirect, of

overdue debts. In addition, a late payment penalty charge shall be applied on any

principal amount not paid within 90 days of the due date.

40. For the purposes of state and federal income taxation, Respondent shall not be entitled,

and agrees not to attempt, to claim a deduction for any civil penalty payment made

pursuant to this CAFO. Any attempt by Respondent to deduct any such payments shall

constitute a violation of this CAFO.

41. Complainant and Respondent shall bear their own costs and attorney fees in this matter.

42. This CAFO shall be binding upon the Respondent, its successors and assigns.

43. Each undersigned representative of the parties to this CAFO certifies that he or she is

fully authorized by the party represented to enter into this CAFO and hereby legally binds

that party to it.
