CONSENT AGREEMENT AND FINAL ORDER

I. <u>STATUTORY AUTHORITY</u>

1.1. This Consent Agreement and Final Order ("CAFO") is issued under the authority vested in the Administrator of the U.S. Environmental Protection Agency ("EPA") by
Section 325 of the Emergency Planning and Community Right-to-Know Act ("EPCRA"), 42
U.S.C. § 11045.

1.2. The Administrator has delegated the authority to issue the Final Order contained in Part V of this CAFO to the Regional Administrator of EPA Region 10, who has redelegated this authority to the Regional Judicial Officer in EPA Region 10.

1.3. Pursuant to EPCRA Section 325, 42 U.S.C. § 11045, and in accordance with the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties,"
40 C.F.R. Part 22, EPA issues, and Chemco, Inc. ("Respondent") agrees to issuance of, the Final Order contained in Part V of this CAFO.

II. <u>PRELIMINARY STATEMENT</u>

2.1. In accordance with 40 C.F.R. §§ 22.13(b) and 22.18(b), issuance of this CAFO commences this proceeding, which will conclude when the Final Order contained in Part V of this CAFO becomes effective.

2.2. The Director of the Office of Compliance and Enforcement, EPA Region 10
("Complainant") has been delegated the authority pursuant to EPCRA Section 325, 42 U.S.C.
§ 11045, to sign consent agreements between EPA and the party against whom an administrative penalty for violations of Section 313 of EPCRA is proposed to be assessed.

2.3. Part III of this CAFO contains a concise statement of the factual and legal basis for the alleged violations of EPCRA together with the specific provisions of EPCRA and the implementing regulations that Respondent is alleged to have violated.

III. ALLEGATIONS

3.1 Under Section 313(a) of EPCRA, 42 U.S.C. § 11023(a), and 40 C.F.R. §§ 372.22 and 372.30, the owner or operator of a facility covered by Section 313 must submit annually, no later than July 1 of each year, a Toxic Chemical Release Inventory Reporting Form, EPA Form 9350-1 ("Form R") for each toxic chemical referenced in Section 313(c) of EPCRA and listed in 40 C.F.R. § 372.65 that was manufactured (including imported), processed, or otherwise used during the preceding calendar year in quantities exceeding the established toxic chemical threshold specified in Section 313(f) of EPCRA, 42 U.S.C. § 11023(f), and 40 C.F.R. §§ 372.25, 372.27, and 372.28.

3.2 The regulations at 40 C.F.R. Part 372 set forth the definitions and requirements for submission of information relating to the release of toxic chemicals under Section 313 of EPCRA.

3.3 Under 40 C.F.R. § 372.22, a facility that meets each of the following criteria in a calendar year is a covered facility for that calendar year and must report under 40 C.F.R. § 372.30:

a. the facility has 10 or more full-time employees;

b. the facility is in a Standard Industrial Classification (SIC) major group or industry code or North American Industrial Classification System (NAICS) code listed in 40 C.F.R. § 372.23; and

c. the facility manufactured (including imported), processed, or otherwise used a toxic chemical in excess of an applicable threshold quantity of that chemical set forth in 40 C.F.R. § 372.25, § 372.27, or § 372.28.

3.4 The toxic chemicals which are subject to the reporting requirement of 40 C.F.R.§ 372.30 are listed at 40 C.F.R. § 372.65.

3.5 Formaldehyde and methanol are toxic chemicals listed at 40 C.F.R. § 372.65. Under 40 C.F.R. § 372.25, the threshold quantity for the manufacture or processing of formaldehyde is 25,000 pounds in one calendar year and the threshold quantity for otherwise use of methanol is 10,000 pounds in one calendar year.

3.6 Under 40 C.F.R. § 372.27, the owner or operator of a facility may apply an alternate threshold of 1 million pounds per year to a toxic chemical if the owner or operator calculates that the facility would have an annual reportable amount of that toxic chemical not exceeding 500 pounds for the combined total quantities that would otherwise be reported in sections 8.1 through 8.7 of Form R. A facility meeting the alternate threshold provisions may submit a certification pursuant to 40 C.F.R. § 372.95 (a "Form A" Report) in lieu of reporting pursuant to 40 C.F.R. § 372.30. However, the alternate threshold provision does not apply to any toxic chemicals listed in 40 C.F.R. § 372.28.

3.7 Respondent is the owner and operator of the Facility located at 4191 Grandview Road, Ferndale, Washington.

3.8 During calendar years 2005, 2007, and 2008, the Facility had 10 or more full-time employees.

3.9 The Facility is included in NAICS codes 321114 and 325998, both of which are included in the list of covered industry codes found at 40 C.F.R. § 372.23.

3.10 The Facility processed more than 25,000 pounds of formaldehyde during calendar years 2007 and 2008 and otherwise used more than 10,000 pounds of methanol during calendar years 2005, 2007, and 2008.

3.11 Respondent failed to file a Form R with EPA and the state of Washington for methanol by July 1, 2006, for calendar year 2005 in accordance with the requirements of 40 C.F.R. § 372.30. Instead, Respondent filed a Form A Report notwithstanding the fact that Respondent did not satisfy the requirements of 40 C.F.R. § 372.27 to use a Form A Report for methanol for calendar year 2005. Respondent filed a Form R Report for methanol covering calendar year 2005 in 2010, subsequent to Complainant's inspection of the Facility.

3.12 Respondent failed to file a Form R report with EPA and the state of Washington for methanol by July 1, 2008, for calendar year 2007 and by July 1, 2009, for calendar year 2008 in accordance with the requirements of 40 C.F.R. § 372.30. Respondent filed a Form R Report for methanol covering calendar year 2007 on August 19, 2008 (49 days late) and a Form R Report for methanol covering calendar year 2008 on March 23, 2010 (265 days late).

3.13 Respondent failed to file a Form A report with EPA and the state of Washington for formaldehyde by July 1, 2008, for calendar year 2007 and by July 1, 2009, for calendar year 2008 in accordance with the requirements of 40 C.F.R. § 372.30. Respondent filed a Form A

Report for formaldehyde for calendar year 2007 on August 19, 2008 (49 days late) and a Form A Report for formaldehyde for calendar year 2008 on March 23, 2010 (265 days late).

IV. CONSENT AGREEMENT

4.1. Respondent admits the jurisdictional allegations contained in Part III of this CAFO.

• 4.2. Respondent neither admits nor denies the specific factual allegations contained in Part III of this CAFO.

4.3. In light of the nature of the violation, Respondent's actions to correct the violations after having been notified by Complainant, and Respondent's willingness to settle this matter without litigation, and in accordance with the *Enforcement Response Policy for Section* 313 of the Emergency Planning and Community Right-to-Know Act and Section 6607 of the Pollution Prevention Act, EPA has determined and Respondent agrees that an appropriate penalty to settle this action is twenty-five thousand four hundred dollars (\$25,400).

4.4. Respondent consents to the payment of the civil penalty set forth in Paragraph 4.3, with interest, according to the following schedule:

4.5. Payment under this CAFO must be made by a check payable to the order of

Respondent must note on the check the title and docket number of this action.

4.6. Respondent must serve photocopies of the check described in Paragraph 4.5 on

4.7. If Respondent fails to pay the penalty assessed by this CAFO in full by the due

date set forth in Paragraph 4.4, the entire unpaid balance of penalty and accrued interest shall become immediately due and owing. Such failure may also subject Respondent to a civil action to collect the assessed penalty under EPCRA Section 325(f), 42 U.S.C. § 11045(f), together with interest, handling charges, and additional non-payment penalties described below.

4.7.1. <u>Interest</u>. Any unpaid portion of the assessed penalty shall bear interest at a rate established by the Secretary of Treasury pursuant to 31 U.S.C. § 3717(a)(1) from the effective date of the Final Order set forth in Part V, provided however, that no interest

shall be payable on any portion of the assessed penalty that is paid in accordance with the payment schedule established in Paragraph 4.4.

4.7.2. <u>Handling Charge</u>. Pursuant to 31 U.S.C. § 3717(e)(1), a monthly handling charge of \$15 shall be paid if any portion of the assessed penalty is more than 30 days past due.

4.7.3 <u>Nonpayment Penalty</u>. Pursuant to 31 U.S.C. § 3717(e)(2), if Respondent fails to pay on a timely basis the penalty set forth in Paragraph 4.3, Respondent shall pay a nonpayment penalty in an amount equal to six percent (6%) per annum on any portion of the assessed penalty that is more than 90 days past due, which nonpayment penalty shall be calculated as of the date the underlying penalty first becomes past due.

4.8. The penalty described in Paragraph 4.3, including any additional costs incurred under Paragraph 4.7, above, represents an administrative civil penalty assessed by EPA and shall not be deductible for purposes of federal taxes.

4.9. The undersigned representative of Respondent certifies that he or she is authorized to enter into the terms and conditions of this CAFO and to bind Respondent to this document.

4.10. The undersigned representative of Respondent also certifies that, as of the date of Respondent's signature of this CAFO, Respondent has corrected the violation(s) alleged in Section III and is currently in compliance with all applicable EPCRA requirements at each of the facilities under its control.

4.11. Except as described in Subparagraph 4.7.2, above, each party shall bear its own fees and costs in bringing or defending this action.

4.12. Respondent expressly waives any right to contest the allegations and waives any right to appeal the Final Order set forth in Part V.

4.13. The provisions of this CAFO shall bind Respondent and its agents, servants, employees, successors, and assigns.

4.14. The above provisions are STIPULATED AND AGREED upon by Respondent and EPA Region 10.

V. FINAL ORDER

5.1. The terms of the foregoing Parts I-IV are ratified and incorporated by reference into this Final Order. Respondent is ordered to comply with the terms of settlement.

5.2. This CAFO constitutes a settlement by EPA of all claims for civil penalties pursuant to EPCRA for the violations alleged in Part III. In accordance with 40 C.F.R. § 22.31(a), nothing in this CAFO shall affect the right of EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law. This CAFO does not waive, extinguish, or otherwise affect Respondent's obligations to comply with all applicable provisions of EPCRA and regulations promulgated or permits issued thereunder.

5.3. This Final Order shall become effective upon filing.
