EXPEDITED SETTLEMENT AGREEMENT

DOCKET NO: CAA-04-2008-8009(b)

This ESA is issued to:

Pilgrim's Pride Corporation

for violating 40 CFR \S 68.67, 40 CFR \S 68.79, 40 CFR \S 68.87 and Section 112(r)(7) of the Clean Air Act.

This Expedited Settlement Agreement (ESA) is being entered into by the United States Environmental Protection Agency (EPA), Region 4, the Director of the Air, Pesticides and Toxics Management Division (Complainant), and by Pilgrim's Pride Corporation (Respondent), pursuant to Section 113(a)(3) and (d) of the Clean Air Act (the "Act"), 42 U.S.C. § 7413(a)(3) and (d), and pursuant to 40 CFR § 22.13(b).

ALLEGED VIOLATIONS

Based on a compliance monitoring inspection conducted at the Respondent's facility located at 3500 Lake Guntersville Park Drive, Guntersville, Alabama, on January 30, 2007, EPA alleges that the Respondent violated the Act's Chemical Accident Prevention Program when Respondent did not provide evidence that:

It has documented the resolution of the 2004 process hazard analysis recommendations (action items) as required by 40 CFR § 68.67(e);

It has promptly corrected the deficiencies (findings or recommendations) noted during the prevention program compliance audit as required by 40 CFR § 68.79(d); and

It has obtained and evaluated information regarding contract employer's safety performance and safety programs as part of its contractor selection process as required by 40 CFR § 68.87(b)(1).

SETTLEMENT

In consideration of Respondent's size, its full compliance history, its good faith effort to comply, and other factors as justice may require, and upon consideration of the entire record the parties enter into the ESA in order to settle the violation cited above, for the total penalty amount of \$810.

This settlement is subject to the following terms and conditions: the Respondent by signing below admits the jurisdictional allegations contained herein, neither admits nor denies the specific factual allegations contained herein, and consents to the assessment of the penalty as stated above; Respondent waives its rights to a hearing afforded by Section 113(d)(2)(A) of the Act, 42 U.S.C § 7413(d)(2)(A), and to contest the allegations contained in this ESA; and each party to this action shall bear its own costs and fees, if any.

Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that the Respondent has corrected the alleged violation listed in this ESA. Respondent shall pay a civil penalty of \$810. Please note that payment <u>should not</u> be made until after Respondent receives a copy of the <u>fully executed</u> ESA. Within fifteen (15) days receiving a copy of the fully executed ESA, the Respondent shall send a cashier's check or certified check (payable to the "Treasurer, United States of America") in the amount of \$810, in payment of the full penalty amount to one of the following addresses:
