REPORT OF STATUS CONFERENCE AND ORDER

A status teleconference in this matter was held on April 27, 2010. Participating were:

Status: Respondent's attorney stated that Respondent found two experts, Dr. Salas and Engineer Bolivar, to complete the study and report on the condition of the site. Dr. Salas and Respondent's attorney visited the property approximately two weeks prior to this conference, the study has been concluded, and a final report was expected on the day of the conference. It was agreed that Complainant would receive a full copy of the report no later than May 3, 2010. The report is to include recommendations, and the Respondent intends to resolve this case by completing any work that needs to be done. Respondent's experts intend to meet with EPA's representative in Puerto Rico, Jose Cedeno.

Complainant's attorney agrees that there has been progress, and that Complainant will review the report within one week following receipt of same. Following review, Jose Cedeno will conduct a follow-up site visit, between the 7th and 14th of May. Dave Pohle and Jose Cedeno will continue to confer on the progress in this matter.

Regarding the penalty, Respondent has met with a CPA to discuss financial information, and will be providing the Complainant with all information bearing on any inability to pay argument that the Respondent intends to make. Respondent intends to

submit this information by May 14, 2010.

Finally, Complainant's attorney informed the undersigned that these status conferences are actually covering two enforcement actions, *In the Matter of Armando Sanchez Crespo*, EPA Docket No. CWA-02-2009-3601 as well as *In the Matter of Praderas Del Mar*, *Inc.*, EPA Docket No. CWA-02-2009-3602. The first represents the Agency's case against the individual owner and operator of the site and the second represents the case against the corporation doing business at the site. To reflect this new information, the Undersigned will issue a report and order under each name and docket number.

The parties and the Undersigned agreed to continue the status teleconference on June 2, 2010 at 10:00AM DST.
