COMES NOW RESPONDENT, O'Reilly Automotive, Inc [hereinafter "O'Reilly"] and requests additional time to respond to the complaint filed by the EPA and for serving notice of opportunity for hearing. In support of this motion and request, the Respondent states as follows:

1. This request follows the unopposed joint motion for extension filed on or about October 12, 2006.
2. This request also follows the unopposed Motion for Extension of Time to Respond to Complaint and Notice of Opportunity for Hearing filed on or about November 22, 2006, from which an Order was entered on November 27, 2006.
3. This request also follows the unopposed Second Motion for Extension of Time To Respond to Complaint and Notice of Opportunity for Hearing filed on or about December 8, 2006, from which an Order was entered on December 12, 2006.
4. O'Reilly and EPA have filed Status Reports as required by the Presiding Officer in this matter.
5. Counsel for the EPA has advised that we have an agreement to resolve the above-referenced matter, but document preparation and final approvals relating to the agency will take longer than the current extension granted. To that end, counsel for the EPA has requested that O'Reilly seek another two-week extension until January 25, 2007.

Wherefore, Respondent O'Reilly respectfully moves the Presiding Officer for an order of an additional extension of time up to and including January 25, 2007, and for other and further relief as is just in the premises.
