ORDER GRANTING MOTION FOR ENLARGEMENT OF TIME TO FILE RESPONDENT'S INITIAL PREHEARING EXCHANGE

On May 17, 2011, Respondent submitted a Motion for Enlargement of Time to File Respondent's Initial Prehearing Exchange in this case. Respondent requests a 10-day extension to file its prehearing exchange on the grounds that Complainant was required to file its initial prehearing exchange on April 29, 2011, but Respondent did not receive a copy of that document until May 10, 2011. Respondent represents that it was unable to confer with counsel for Complainant to determine whether she had any objection prior to the filing of the Motion.

For good cause shown, Respondent's Motion is hereby GRANTED. Accordingly, Respondent's prehearing exchange shall be filed on or before June 6, 2011.1/ In turn, Complainant shall file any rebuttal prehearing exchange on or before June 20, 2011.
