NOTICE OF HEARING



No dispositive motions may be filed after July 7, 2008. In addition to complying with the procedural rules requirements regarding filing, motions are also to be filed by facsimile with the Court.

In addition to the paper filing requirements for motions and post-hearing briefs, as set forth at 40 C.F.R § 22.26, the parties are to submit, to the court only, a CD version of such filings and replies thereto. The parties are advised that the purpose behind this requirement is to make it possible for the Court to quote liberally from those documents in creating its orders and decisions. Please do not have the disk version of the document encoded or otherwise adorned with boxes which make it difficult or impossible to cut and paste from those submissions, as that defeats the purpose of the requirement.

The parties are directed to confer and acting in good faith, stipulate to those facts which are not genuinely in dispute, so that the hearing may be more efficiently conducted.


