ANSWER OF RESPONDENT, CLEAN HARBORS ENVIRONMENTAL SERVICES, INC., AND REQUEST FOR HEARING

NOW COMES respondent, CLEAN HARBORS ENVIRONMENTAL SERVICES, INC. (hereinafter "Respondent"), through its undersigned representative, and responds to the COMPLAINT AND NOTICE OF OPPORTUNITY FOR HEARING ("Complaint") filed by the U.S. Environmental Protection Agency Region 2 ("Complainant"), by hereby requesting an adjudicatory hearing, and through the responses and defenses set forth herein.

<u>I.</u>

Respondent was served with this Complaint on October 10, 2008 by means of certified First Class Mail. Respondent's Answer and Request for Hearing are hereby timely filed on December 17, 2008, in compliance with the 90 day response timeframe set forth in the Complaint.

II.

For convenient reference, the alleged violation set forth in the order is set forth *in verbatim* below, followed by Respondent's answer:

COUNT 1: Manifesting PCBs

Circumstance Level – 1
major manifesting
Extent Category – **Major**amount over 6,000 kilograms
Proposed Penalty for this Count:

Response:

Respondent admits the factual allegations as set forth in paragraphs 12 through 15 of Count 1 of the Complaint with the exception of paragraph 13 for the weight of the material as 13,925 kilograms. Respondent denies the total weight. The original bill of lading listed the volume of material in cubic yards. Respondent also denies the appropriate civil penalty has been assessed for the two reasons set forth below.

Defense Argument 1. – The penalty assessed is inconsistent with the POLYCHLORINATED BIPHENYLS (PCB) PENALTY POLICY

On page 3 of the United State Environmental Protection Agency POLYCHLORINATED BIPHENYLS (PCB) PENALTY POLICY (the "Penalty Policy"), dated April 9, 1990 section 1.a., second paragraph, states:

"The only acceptable alternative to compliance with the non-disposal requirements of the PCB rules is lawful disposal. Accordingly, a fair penalty for violating the non-disposal requirements can be based on the proper disposal of PCBs or PCB items. This should provide adequate incentive to comply with the non-disposal requirement.".

This non-disposal manifesting issue was caused by human error. Respondent had multiple analytical data reports for multiple remediation projects. Respondent's employee erred by associating the wrong analytical report with the shipment and thus classifying the waste as material with less than 50 PPM PCBs when the waste actually had greater than 50 ppm PCBs. Upon discovery of the error on the day following the shipment, the waste was recharacterized as PCB waste with greater than 50 ppm PCBs and disposed of in a TSCA permitted hazardous waste landfill.

The original waste had been mixed with other material in a container at Clean Harbors of Baltimore, Inc. All the original waste plus the material contaminated by contact was disposed of at Clean Harbors Grassy Mountain, LLC. 29,090 Kg of material was disposed of as PCB contaminated material. The cost for the transportation, disposal and assessorial charges was \$12,547.49. Since a Clean Harbors company provided the disposal, there is no invoice. Charges were calculated and assessed by internal documentation. Refer to the e-mail in Attachment 1.

Had 3rd party disposal been used, the waste would have been disposed of at Chemical Waste Management's facility in Model City, NY. The cost of transportation and disposal at this facility would have been \$6,319.50. See Attachment 2 for quotations and calculations of the total cost.

The Respondent hereby requests the penalty to be adjusted to \$6,319.50.

Defense Argument 2. – This penalty should be a "Significant" Extent under the Penalty Policy

The volume of material transported on bill of lading No. 179520 was 15 cubic yards of material. One cubic yard of soil is the equivalent of four 55 gallon drums. Fifteen cubic yards is therefore, sixty 55 gallon drum equivalents. Per page 4 of the Penalty Matrix, 15 to 75 55-gallon drums is a Significant Extent for Non-Disposal Violations. More than 6,000 Kg is a Major Extent. The Penalty Policy is internally inconsistent whereby this waste could be classified as Major or Significant depending on whether the material was measured by weight or 55 gallon drum equivalents. Respondent hereby requests the penalty be adjusted to reflect a lesser Extent.

III.

Please note that the Respondent participated in an informal settlement conference via conference call on November 19, 2008 with Agency representatives. The Agency representatives indicated they were not authorized to respond to a request to assess the penalty at the actual cost of disposal in lieu of the amount calculated by the Penalty Matrix and that a formal hearing would need to be requested to respond to that request. Respondent therefore requests a hearing to advance this position.

Respondent is submitting this request for hearing as a protective pleading to preserve all legal rights with respect to the allegations. However, Respondent is still willing to negotiate a mutually acceptable settlement. Provided such a settlement can be reached, Respondent would withdraw its

request for a hearing.
