Dear Ms. Milligan:

On September 19, 2013, the U.S. Environmental Protection Agency (EPA) issued an Administrative Order (Order) ordering Dreaming Tree, LLC (LLC), as owner and/or operator of The Other End public water system, to comply with various regulations issued by the EPA to the Safe Drinking Water Act (SDWA).

Our records indicate that the LLC is again in violation of the Order. Among other things, the Order included the following requirements (from paragraph 19 on page 3 of the Order) in which the LLC is named as Respondent:

 Respondent shall monitor the System's water quarterly for total coliform bacteria and, if any sample is positive for total coliform, conduct repeat and additional routine monitoring, as required by 40 C.F.R. § 141.21. Within the first 10 days following the month in which sample results are received, Respondent shall (a) report any analytical results to the State, as required by 40 C.F.R. § 141.31(a), and (b) provide the EPA with a copy of the results.

The EPA has not received total coliform bacteria analytical results for 4<sup>th</sup> quarter 2013.

The EPA is considering additional enforcement action as a result of the LLC's non-compliance with the Order. Violating an administrative order may lead to (1) a penalty of up to \$37,500 per day per violation of the order, and/or (2) a court injunction ordering compliance.
