

III. Desired or Required Hearing Location

Complainant prefers the Court hold the hearing in Chicago, Illinois, as provided by sections

22.21(d) and 22.19(d) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation or Suspension of Permits (“the Consolidated Rules”), 40 C.F.R. §§ 22.21(d) and 22.19(d).

However, if the Court chooses to hold the hearing at a suitable location in the county where the Respondent resides (Kane and DuPage Counties, Illinois) or conducts the business which the hearing concerns (Kane and DuPage Counties, Illinois), Complainant would not object.

Complainant requests approximately four (4) hours to complete its direct-examination of its witnesses for its case-in-chief.
