## STATUS REPORT

This Status Report is filed by Complainant's counsel in response to your Honor's Prehearing Order of June 8, 2009. I am pleased to report that the parties have reached a settlement in this matter, pending memorialization of the terms and conditions of settlement in a Consent Agreement/Final Order ("CA/FO"). Specifically, the parties have agreed to a civil penalty amount and the performance by Respondent of a Supplemental Environmental Project ("SEP").

Given the nature of the SEP, EPA Headquarters needs to approve it. As such, Complainant's counsel has prepared a memorandum to HQ requesting their approval of this SEP. The memo is currently undergoing internal concurrence at EPA, Region 2 offices. Complainant's counsel expects to send the memorandum to EPA Headquarters by July 13, 2009. EPA Headquarters may take several weeks to review and approve of the SEP.

Additionally, Complainant's counsel has drafted a Consent Agreement/Final Order, which is currently undergoing internal review, before it can be sent to Respondent's counsel. Complainant's counsel expects to send a draft CA/FO to Respondent's counsel by July 13, 2009.

Given the complexity of this settlement, which involves a SEP, it has taken several weeks to draft the CA/FO. Also, it will take several weeks to secure the approvals required within different offices of EPA. Accordingly, Complainant's counsel anticipates that Complainant will need to file, within the next few weeks, a Joint Motion requesting an extension of time to file its Prehearing Exchange, so that both parties can devote their resources to getting the CA/FO reviewed, approved and ratified by both parties. Complainant's counsel has consulted with Respondent's counsel, who indicates he will join in the motion for extension of time.
