PUBLIC NOTICE AND OPPORTUNITY TO COMMENT ON CLEAN WATER ACT SETTLEMENT

Action: EPA is providing notice of a Combined Complaint and Consent Agreement with penalty assessment and the opportunity for public comment on the proposed administrative penalty assessment against Peter K. Roosevelt for noncompliance with the Oil Pollution Prevention regulations, 40 C.F.R. part 112.

Summary: EPA is authorized in Class II proceedings under section 311(b)(6) of the Clean Water Act (Act), 33 U.S.C. § 1321(b)(6), to issue orders assessing civil penalties for violations of the Act and its implementing regulations, after providing the person subject to the penalty notice an opportunity for a hearing, and after providing the public with notice of the proposed penalty and the opportunity to submit written comments and to participate in a Class II penalty proceeding (hearing), if any. The deadline for submitting public comment is thirty (30) calendar days after issuance of this notice.

On [~~SEP 15~~ 2017, EPA filed a Combined Complaint and Consent Agreement pursuant to section 311(b)(6)(B)(ii) of the Act. Pursuant to section 311(b)(6)(C)(i) of the Act, and 40 C.F.R. § 22.45, EPA hereby notifies the public of this proposed penalty assessment:

Proposed penalty in the Complaint: \$50,000.

Alleged violations: Failure to prepare and implement written Spill Prevention, Control and Countermeasure (SPCC) plans for the Porter 6-21, 11-25 Barker, and 13-17 Benton production facilities owned and/or operated by Peter K. Roosevelt, in violation of 40 C.F.R. part 112 and 311(j) of the Act, 33 U.S.C § 1321(j).

Written comments on the Combined Complaint and Consent Agreement are encouraged and will be accepted at the address listed below for a period of thirty (30) calendar days after the publication of this notice. Written comments submitted by the public, as well as information submitted by Peter K. Roosevelt, will be available for public review, subject to the provisions of law restricting the disclosure of confidential information. Any person submitting written comments has a right to participate in a hearing, if one is held.
