Complainant United States Environmental Protection Agency, Region 8 (EPA), by and through its undersigned attorney, provides the following Settlement Status Report in the above-referenced consolidated matter pursuant to the Order Postponing Hearing issued by the Honorable Barbara A. Gunning, Administrative Law Judge, dated September 26, 2008.

1. The Regional Judicial Officer for EPA Region 8 approved and incorporated by reference into a Final Order a fully-executed Consent Agreement resolving In the Matter of Burke Oil Company, Inc., Docket No. CWA-08-2007-0026, on September 29, 2008.

2. Mr. Robert Burke on behalf of the Respondent committed to addressing the outstanding Spill Prevention, Control, and Countermeasure (SPCC) compliance issues EPA communicated electronically to the Respondent on September 23, 2008, pertaining to the Presho Oil facility as a precursor to commencing settlement discussions.

3. Respondent's Counsel, in a letter to EPA and related attachments sent September 23, 2008, communicated Respondent's plans to update the SPCC plan for, upgrade the secondary containment berms at, and remove the 2000 gallon above ground storage tank

from the Presho facility.

4. Respondent has not provided EPA with an updated SPCC plan or notified EPA that the noncompliance referenced in paragraph 3 above or otherwise listed in the September 23, 2008 e-mail from EPA has been performed.

5. EPA contacted Respondent's Counsel on November 4, 2008, requesting a compliance update.


6. EPA received a phone call from Respondent's Counsel's Office on November 5, 2008, stating that no report had been received yet from the Professional Engineer, but that the Respondent would provide EPA with a copy upon receipt.

7. EPA provided Respondent's Counsel with proposed Joint Stipulations of Facts, Exhibits, and Testimony for review and input on November 6, 2008, to facilitate satisfying the Judge's deadline of December 30, 2008, as set forth in the Order Postponing Hearing.

8. The Parties plan will file a follow-up Settlement Status Report with the Administrative Law Judge on December 11, 2008, should the parties have not settled the matter and filed a fully-executed Consent Agreement and Final Order by that date.
