

Pursuant to Section 22.16 of the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/ Termination or Suspension of Permits" (Consolidated Rules), 40 C.F.R. § 22.16, Complainant, the Director of the Land and Chemicals Division, United States Environmental Protection Agency (EPA), Region 5, by and through his attorney, hereby responds to the Motion to Quash Service of Process submitted on behalf of Respondents Dudley B. Burrell and the Dudley B. Burrell Trust.

Respondents Dudley B. Burrell and the Dudley B. Burrell Trust seek to quash service on the basis of Dudley B. Burrell's statements that he is separated from his wife and told her not to receive service. However, Dudley B. Burrell admits that he was and is still married to Willie P. Burrell.


Dudley B. Burrell was served as an individual through his wife, Willie P. Burrell, at a location previously listed as his address and that he continues to use for leasing and other purposes. Dudley B. Burrell admits that at all relevant times he has been married to

Willie P. Burrell. Willie Burrell signed for Dudley Burrell at the 300 Indiana Avenue address. (See green cards in Attachment 1.) As discussed in the enclosed Memorandum, Dudley Burrell has used this address. (See Attachments 1, 3 and 5.) He has also listed this address on the return address area of the envelopes addressed to Respondent's Counsel containing his January 12, 2011 request for settlement conference and Motion for Extension of Time. (See Attachment 4.) In addition, he appears to have filed tax returns jointly with Willie P. Burrell, using that address for at least years 2007 through 2009. (See tax returns attached to Respondents Willie P. Burrell and the Willie P. Burrell Memorandum in Support of Respondents' Motion Opposing Motion for Default Judgment and Respondents' Motion to Dismiss.)

A Memorandum in Opposition to Respondents Dudley B. Burrell and Dudley B. Burrell Trust Motion to Quash Service of Process and Motion to Dismiss for Defective Service of Process is also enclosed.

Respondent's motion should be denied, and a ruling in favor of Complainant should be granted.

COMPLAINANT'S RESPONSE TO RESPONDENTS DUDLEY B. BURRELL AND  
THE DUDLEY B. BURRELL TRUST MOTION TO DISMISS FOR DEFECTIVE  
SERVICE OF PROCESS

Pursuant to Section 22.16 of the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits" (Consolidated Rules), 40 C.F.R. § 22.16, Complainant, the Director of the Land and Chemicals Division, United States Environmental Protection Agency (EPA), Region 5, by and through his attorney, hereby responds to the Motion to Dismiss for Defective Service of Process submitted on behalf of Respondents Dudley Burrell and the Dudley Burrell Trust.

Respondents Dudley B. Burrell and the Dudley B. Burrell Trust claim that the proof of service of the Complaint was defective. However, in fact, the return receipts were properly executed. They show the date of filing as well as the date of receipt and signature. As set forth in the attached declaration of the Regional Hearing Clerk on File Stamp Dates on Certified Mail Receipts, she wrote the date of the Regional Hearing Clerk file stamp that she saw on the front side of the card on the back side of the cards,

prior to scanning them; the signature dates indicating receipt of the complaint were not altered; documents, including green cards, are stamped with the Regional Hearing Clerk file stamp on the date they are filed in the Regional Hearing Clerk's Office; and the green cards addressed to Dudley Burrell and the Dudley Burrell Trust were stamped with the Regional Hearing Clerk's file stamp, and show a filing date of July 18, 2006.

The insertion by the Regional Hearing Clerk of the date of filing on the signature side of the green card does not vitiate proof of service. A Memorandum in Opposition to Respondents Dudley B. Burrell and Dudley B. Burrell Trust's Motion to Quash Service of Process and Motion to Dismiss for Defective Service of Process is also enclosed.

Respondent's Motion should be denied, and a ruling in favor of the Complainant should be granted.

COMPLAINANT'S MEMORANDUM IN OPPOSITION TO RESPONDENTS  
DUDLEY B. BURRELL AND THE DUDLEY B. BURRELL TRUST MOTION TO  
QUASH SERVICE OF PROCESS AND MOTION TO DISMISS FOR DEFECTIVE  
SERVICE OF PROCESS

Complainant, the Director of the Land and Chemicals Division, United States Environmental Protection Agency (EPA), Region 5, by and through his attorney, herewith submits this memorandum, together with the annexed Declaration of the Regional Hearing Clerk on File Stamp Dates on Certified Mail Receipts, in opposition to Respondents' Motion to Quash Service of Process and Motion to Dismiss for Defective Service of Process.

Respondents Dudley B. Burrell and the Dudley B. Burrell Trust seek to quash service on the basis of Mr. Burrell's statements that he separated from his wife and told her not to receive service and to dismiss the Complaint on the basis that the Regional Hearing Clerk inserted the date of filing on the signature side of the green cards.

I. Dudley Burrell Was Served with the Complaint

As discussed in Complainant's December 17, 2011 Motion for Default Order, Dudley B. Burrell was served as an individual through his wife, Willie P. Burrell, at a

location previously listed as his address. This constitutes substitute service under Rule 4(e) of the Federal Rule of Civil Procedure and 735 Ill. Comp. Stat. 5/2-203(a).

In *C.W. Smith*, Docket No. CWA-04-2001-1501, 2002 EPA ALJ LEXIS 7 (ALJ, Order on Motions, February 6, 2002), Administrative Law Judge McGuire held that where the Complaint was sent by certified mail with return receipt requested and addressed to a mailing address that the Respondent had employed as a mailing address for legal documents, the Complainant could reasonably expect that service to that address would achieve actual service of process. The mails may be used to effectuate service of process if the notice reasonably conveys the required information and affords a reasonable time for response and appearance. See *C.W. Smith*, Docket No. CWA-04-2001-1501, 2002 EPA ALJ LEXIS 7 (ALJ, Order on Motions, February 6, 2002). *C.W. Smith* followed the 10<sup>th</sup> Circuit's holding in *Katzon Brothers, Inc. v. United States Environmental Protection Agency*, that the rules of Practice and the requirements of due process alone determine whether EPA's service of process is proper, and certified mail service under the Rules of Practice does not require actual delivery, and upheld the Regional Judicial Officer's holding in *Herman Roberts* that a person who signs a certified mail receipt green card and picks up mail at a respondent's business post office box is authorized to receive service of process under the Rules of Practice. *C.W. Smith*, Docket No. CWA-04-2001-1501, 2002 EPA ALJ LEXIS 7 (ALJ, Order on Motions, February 6, 2002) (citing *Katzon Brothers, Inc. v. United States Environmental Protection Agency*, 839 F.2d 1396, 1399 (10th Cir. 1988) and *Herman Roberts*, Docket No. OPA-99-512, 2000 EPA RJO LEXIS 211 (RJO, "Order," April 14, 2000)). In *C.W. Smith*, the

Respondent had also averred that the person who signed for him was not authorized to accept process on his behalf. *See id.*

What is or is not a party's "'dwelling house or usual place of abode' within the meaning of the rule or statute is a question to be determined on the facts of the particular case." *Kalsson v. Rabinowitz*, 318 F.2d 666, 668 (4th Cir. 1963) (citing 2 James Wm. Moore Et Al., *Moore's Federal Practice* ¶ 4.11 (2d ed. 1962)).

300 North Indiana Avenue, Kankakee, Illinois has been listed as a prior address for Dudley Burrell (Attachment 1), it was the address of the inspection, and Mrs. Burrell signed for him at that address. (*See Green Cards in Attachments 2*) On the internet, Dudley Burrell is listed as a contact for the leasing at this address.<sup>1</sup> (*See Attachment 3.*) While the lines on the envelope are overlapped, 300 North Indiana Avenue was the address on the return address area of the envelopes addressed to Respondent's Counsel containing his January 12, 2011 request for settlement conference and Motion for Extension of Time, listing the Dudley Burrell Trust as the sender. (*See Attachment 4.*) Dudley Burrell used the 300 Indiana Avenue address as his registered address for his former company. (*See Attachment 5.*) Moreover, based on his wife's pleadings, it appears that Mr. Burrell filed his tax returns jointly with his wife Willie Burrell, using the 300 North Indiana Avenue address from at least 2007 through 2009. (*See tax returns attached to Respondents Willie P. Burrell and Willie P. Burrell Trust Memorandum in Support of Respondents' Motion Opposing Motion for Default Judgment and Respondents' Motion to Dismiss.*)

<sup>1</sup> In his affidavit, Mr. Burrell States that B&D Management Inc. was a closely held company owned and operated by him and his wife and that at all times alleged in the complaint, it was the company responsible for leasing apartment units owned by him, his wife and their trusts, but, as discussed in Complainant's Memorandum in Support of Motion for Default Order, that corporation was dissolved at the time the leases at issue were executed and Mr. Burrell signed one of the leases.

Merely by moving into a new residence a defendant does not necessarily prevent his previous dwelling from being his “usual place of abode.” *United Bank of Loves Park v. Dohm*, 450 N.E.2d 974, 977 (Ill. App. 2d Dist. 1983) (citing *Rich Products Corp. v. Diamond*, 51 Misc. 2d 675 (N.Y. Sup. Ct. 2d 1966)); *Minnesota Mining & Manufacturing Co. v. Kierkevold*, 87 F.R.D. 317, 323-24 (D. Minn. 1980); *Karlsson v. Rabinowitz*, 318 F.2d 666 (4th Cir. 1963). Service of the administrative complaint by certified mail with return receipt requested to the address most recently provided satisfies due process concerns. See *U.S. v. Serfling*, 1998 U.S. District LEXIS 3566 (N.D. Ill, E. Div. 1998) (service effectuated when certified mail was returned as “unclaimed”).

Respondents assumes that it is too late to serve the Complaint, because there is a five year statute of limitations. In Illinois, however, actions are commenced by the filing of a complaint. *Bemis & Associates v. SafeCo Insurance Co.*, 2009 U.S. Dist. LEXIS 58145 (S.D. Ill. July 8, 2009), *aff'd*, 585 F. 3d 326 (7<sup>th</sup> Cir. 2009). The filing of a complaint tolls the statute of limitations. *Appleton Electric Co. v. Graves Truck Lines, Inc.*, 635 F. 2D 603, 608 (7<sup>TH</sup> Cir. 1980), *cert. denied*, 451 U.S. 976 (1981), citing *U.S. v. Wahl*, 583 F. 2d 285 (6<sup>th</sup> Cir. 1978) (where the complaint was served three years after filing).

Complainant could reasonably expect that service of Dudley Burrell at the 300 North Indiana address achieved actual service. Here, unlike in *Williams v. Capital Transit Co.*, where the Defendant divorced his wife, Dudley Burrell is still married to Willie Burrell and continues to use the address where the Complaint was served. (See generally *Williams v. Capital Transit Co.*, 215 F.2d 487, 489 (D.C. Cir. 1954). In his affidavit, Dudley B. Burrell admits that at all relevant times he has been legally married

to Willie P. Burrell and that at least from 1979 to 2003, he used 300 North Indiana Avenue as at a business address. As discussed above, Mr. Burrell recently mailed his request for extension in an envelope with the return address of 300 North Indiana Avenue address, where the Complaint was served upon his wife, and is still listed as the contact for apartment leasing at that address. He responded to the Motion served at that address, and appears to have filed tax returns jointly with his wife from that address in recent years.

## II. Proof of Service was Valid

The Motion to Dismiss claims that it cannot be determined when the green cards were actually filed. The certificates of service filed with the Regional Hearing Clerk for Dudley B. Burrell and the Dudley B. Burrell Trust indicate that they were stamped July 18, 2006. (See green cards in Attachment 2). Respondent's counsel attests that it is the customary practice of the government to date stamp the green cards on the same side as the purported signature. As set forth in the attached Declaration of the Regional Hearing Clerk on File Stamp Dates on Certified Mail Receipts, she wrote the date of the Regional Hearing Clerk file stamp that she saw on the front side of the card on the back side of the cards, prior to scanning them; the signature dates indicating receipt of the Complaint were not altered; documents, including green cards, are stamped with the Regional Hearing Clerk file stamp on the date they are filed in the Regional Hearing Clerk's Office; and the green cards addressed to Dudley Burrell and the Dudley Burrell Trust were stamped with the Regional Hearing Clerk's file stamp, and show a filing date of July 18, 2006. While it is the current hearing clerk's practice to insert the filing date on

the signature side of the cards, for scanning, there is no policy dictating which side of the card to file stamp.

The green cards had been file stamped with the Regional Hearing Clerk file stamp, and the current Regional Hearing Clerk's wrote in the file stamp date from the front of the card on the back of the card for scanning. The green cards contain the signature and date of signing by Willie P. Burrell as well as the file stamp date of the Regional Hearing Clerk. (See green cards in attachment 1). Willie Burrell signed the green cards for her husband Dudley B. Burrell and as an agent for his trust on July 10, 2006. (See green cards in Attachment 2).

A properly executed return receipt constitutes proof of service of the Complaint. *In the Matter of Bobby Rowe Energy, Inc.*, Docket No. CWA-06-2009-1761, RJO LEXIS (RJO, July 6, 2010); *In the Matter of K Industries, Inc.* Docket No. RCRA-06-2003-0915, 2005 EPA RJO LEXIS 109 (RJO, March 2, 2005). The insertion of the filing date on the back side of the green card by the Regional Hearing Clerk does not vitiate the proof of service. All indications are that service was completed as set forth in the green cards.

#### CONCLUSION

For the reasons set forth above and in Complainant's Motion for Default and accompanying documentation, Complainant moves this Court for a Default Order that includes the following: 1) finding all of the facts in the Complaint admitted; and 2)

assessing a civil penalty in the amount of \$89,430 as pled in the Complaint and based on the admitted facts.

**DECLARATION OF LADAWN WHITEHEAD ON FILE STAMP DATES ON  
CERTIFIED MAIL RECEIPTS**

I, LADAWN WHITEHEAD, declare and state as follows:

1. I currently am employed as the Regional Hearing Clerk (RHC) with Region 5 of the U.S. Environmental Protection Agency (EPA). I have been employed with EPA since September of 1988 and have held the position of RHC since April, 2009.

2. The general responsibilities of an RHC are set forth in 40 C.F.R. Part 22. As an RHC, I am responsible for maintaining the official files for all pleadings, including complaints and any documents filed subsequent to a complaint, in administrative cases initiated by EPA Region 5 for violations of, *inter alia*, the Toxic Substances Control Act (TSCA), 15 U.S.C. § 2601 *et seq.* As part of my duties, I receive, date-stamp and file pleadings served on the Region in TSCA administrative cases. Additionally, I am designated and required to create and maintain a docket or index of the administrative record. 40 C.F.R. § 24.03.

3. I also scan documents to save them as a PDF file for entry into the Regional Hearing Clerk Database. The Regional Hearing Clerk's Database (RHC Database) was established on January 1, 2007, as an electronic version of the principal pleadings for the

Agency's administrative cases that is maintained by the Washington, D.C. office. As the RHC Database developed and improved, it evolved into an electronic copy of the full administrative case docket, containing all of the pleadings filed in the case (except for the most voluminous attachments, confidential business information and privacy information). Since April 2009, I have been responsible for adding new documents to this Database that are filed in Region 5.

4. Documents, including certified mail receipts (green cards), are stamped with the Regional Hearing Clerk file stamp on the date they are filed in the Regional Hearing Clerk's office.

5. Because it is part of the administrative case record, green cards received by the RHC are scanned into the RHC Database.

6. The Regional Hearing Clerk's Office does not have a policy governing which side to file stamp a document.

7. Because the relevance of the green card to the case record is the signature side of the card, which shows the date of delivery and the name of the person who signed for the mailing package, it is my custom to stamp the filing date on the signature side of the card so that all of this information is available in a single image.

8. Other people, including previous RHCs, have sometimes stamped the filing date of the green card on the front side of the card where the mailing address of the Agency is written.

9. When I find that the filing date has been stamped on the front of the green card as I prepare to scan the green card into the RHC Database, my custom is to copy that filing date onto the signature side of the card.

10. I do not alter the dates of signature.

11. The green cards addressed to Dudley Burrell, the Dudley Burrell Trust, and the Willie P. Burrell Trust of the complaint filed *In the matter of: Willie P. Burrell, The Willie P. Burrell Trust, Dudley B. Burrell, and The Dudley B. Burrell Trust* (TSCA-05-2006-0012) were stamped with the Regional Hearing Clerk's file stamp before I became RHC, and show a filing date of July 18, 2006.

12. The green card addressed to Willie P. Burrell of the complaint filed *In the matter of: Willie P. Burrell, The Willie P. Burrell Trust, Dudley B. Burrell, and The Dudley B. Burrell Trust* (TSCA-05-2006-0012) was file stamped with the Regional Hearing Clerk's file stamp before I became RHC, and shows a filing date of July 17, 2006.

13. I wrote in the date of that Regional Hearing Clerk file stamp that I saw on the front side of the card on the back side of the cards, prior to scanning them.

14. On the green cards for Willie P. Burrell and the Willie P. Burrell Trust, I had initially written an incorrect filing date that did not match the filing date stamped on the front of the green card.

15. I used white out when I corrected the date I had entered on the back side of these the green cards so that each showed the true filing date stamped on the front side.

16. The filing dates I wrote on the back side on the green cards for Dudley B. Burrell and the Dudley B. Burrell Trust did not need correction.

17. I did not alter the original filing date stamped on the front of any green cards for the complaint filed *In the matter of: Willie P. Burrell, The Willie P. Burrell Trust, Dudley B. Burrell, and The Dudley B. Burrell Trust*.

18. I made no other changes to the green cards.

19. I am attaching copies of both sides of the green cards showing service of the Complaint filed *In the matter of: Willie P. Burrell, The Willie P. Burrell Trust, Dudley B. Burrell, and The Dudley B. Burrell Trust.*




