ORDER GRANTING MOTION TO WITHDRAW APPEAL

On March 6, 1998, EPA filed a motion to withdraw its appeal, CWA Appeal No. 96-6. As grounds for the motion, counsel represents that additional research into the matters which formed the basis for its appeal reveals that continued pursuit of the appeal "is not good use of the Board's or Respondent's time."
