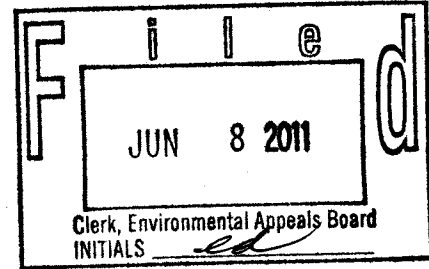

(collectively "RCRA"), 42 U.S.C. § 6928(a), the Consent Agreement resolving this matter is hereby approved and incorporated by reference into this Final Order. Respondents are hereby ordered to comply with the terms of the Consent Agreement, effective immediately.


