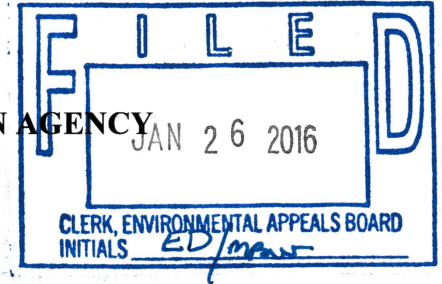

ORDER RESCHEDULING ORAL ARGUMENT

In an order dated October 30, 2015, the Environmental Appeals Board (“Board”) scheduled oral argument in this case for Thursday, January 28, 2016. However, given this past weekend’s blizzard and the significant impacts to the mid-Atlantic region, the Board determined Monday morning, January 25, that the prudent course would be to reschedule the oral argument. The Board’s Clerk promptly notified the parties by e-mail that the Board was rescheduling the argument for Tuesday, February 9, 2016, and that the Board would issue an order to that effect.

Accordingly, the parties are ordered to participate in oral argument on Tuesday, February 9, 2016, beginning at 10 AM Eastern Standard Time in the Administrative Courtroom located at the U.S. Environmental Protection Agency, William Jefferson Clinton East Building, Room 1152, 1201 Constitution Avenue, N.W. Washington D.C. The Board has allocated sixty minutes for oral argument, divided as follows and in the following order: (1) thirty minutes for Petitioner, City of Taunton; (2) thirty minutes for Respondent, EPA Region 1. At the outset of the proceedings, each side may reserve up to five minutes of its allocated time for rebuttal.

The Board has received the parties’ notification of counsel who will present oral argument, as well as the names of other officials and engineers from the City who will attend.

Any change as to who will present argument or attend shall be communicated to the Clerk of the Board in writing no later than February 2, 2016.¹
