### I. <u>PRELIMINARY STATEMENT</u>

- This is a civil administrative proceeding for the assessment of a civil penalty instituted pursuant to Section 309(g) of the Clean Vater Act ("CWA" or "the Act"), 33 U.S.C. § 1319(g).
- 2. The following Findings of Fact are made and Order issued pursuant to the authority vested in the Administrator of the United States Environmental Protection Agency ("EPA") by the Act, 33 U.S.C. § 1251 *et. seq.*, which authority has been duly delegated to the Regional Administrator of Region 2, EPA and since further re-delegated to the Director, Division of Enforcement and C ompliance Assistance, Region 2, EPA.
- 3. EPA is initiating and concluding this preceding for the assessment of a civil penalty, pursuant to Section 309(g) of the Clean Water Act, 33 U.S.C. §1319(g), and 40 CFR §22.13(b) of the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders, and the Revocation, Termination or Suspens on of Permits" (CROP), which sets forth procedures for simultaneous commencement and conclusion of administrative civil penalty assessment proceedings through issuance of a consent agreement and final order pursuant to 40 C.F.R. § 22.18 (b)(2) and (3).

# II. FINDINGS OF FACT

- 4. College Point Yacht Club, Inc. (hereinatter, "Respondent") is a corporation, duly organized under the laws of the State of New York.
- 5. Respondent operated a facility located a 3-04 126th Street, College Point, New York (the "facility") where the facility is primarily involved in the operation of a marina/yacht club.

- 6. At all times relevant to this Administrative Complaint, Respondent was a "source" within the meaning of Section 306(a)(3) of the Act, 33 U.S.C. §1316(a)(3).
- 7. EPA determined that Respondent has disc harged stormwater associated with industrial activity from its facility directly to a navi sable water of the United States (Flushing Bay), pursuant to Section 502(7) of the Act, 33 U.S.C. §1362(7).
- 8. The Respondent's Facility discharged sto mwater runoff to Flushing Bay, as referenced in paragraph 7 above, without a State Pol utant Discharge Elimination System ("SPDES") General Permit for Stormwater Discharges Associated with Industrial Activity.

### III. CONCLUSIONS OF LAW AND JURI SDICTION

- 9. Section 301(a) of the Act, 33 U.S.C. §13 1(a), provides, in part, that the discharge of any pollutants by any person from a point source to a navigable water of the United States shall be unlawful except, *inter alia*, in accordance with the terms and conditions of a duly issued permit pursuant to Section 402 of the Act, 33 U.S.C. §1342.
- 10. Section 402 of the Act, 33 U.S.C. §1342, authorizes the Administrator of EPA to issue a National Pollutant Discharge Elimination System ("NPDES") permit for the discharge of any pollutant, or combination of pollutan s, subject to certain requirements of the Act and conditions which the Administrator deter nines are necessary.
- 11. Pursuant to Section 402(b) of the Act, 33 U.S.C. §1342(b), EPA granted authority to the New York State Department of Environm ental Conservation ("NYSDEC") to issue State Pollutant Discharge Elimination System ("SPDES") permits to facilities in New York State for the discharge of pollutants from said facilities from a point source to a navigable water of the United States.
- 12. Section 402(p) of the CWA, 33 U.S.C. § 342(p) sets forth the requirements for the discharges of stormwater.
- 13. The terms "Industrial Stormwater Permit', "Multi Sector General Stormwater Permit" or "MSGP" mean the New York State Department of Environmental Conservation (NYSDEC) interim SPDES Multi-Sector General Permit (MSGP) Permit for Stormwater Discharges Associated with Industrial Activity (GP-0-11-009) and/or the previous Industrial Stormwater Permit (GP-0-06-032). The most recent MSGP (GP-0-11-009) was issued by the NYSDEC became effective on March 28, 2012 and expired on September 30, 2012. GP-0-11-009 replaced GP-0-06-002, which became effective on March 28, 2007 and expired on March 27, 2012.

- 14. The Administrator of EPA has promulga ed regulations, 40 CFR §122.26(a)(1)(ii) and §122.26(b)(14), which require operators o obtain a NPDES permit for stormwater discharges associated with industrial activity. The regulations at 40 CFR §122.26(b)(14) establish requirements for stormwater discharges associated with industrial activity.
- 15. Respondent has conducted industrial activity under SIC Code 4493 and therefore is regulated under 40 CFR 122.26 and the NYSDEC MSGP.
- 16. The SPDES MSGP and regulations for stormwater discharges at 40 CFR §122.26(b)(14) apply to this facility.
- 17. The Respondent's Facility is subject to the NPDES requirements pursuant to Section 402 of the Act, 33 U.S.C. §1342 and Section 301(a) of the Act, 33 U.S.C. §1311(a).
- 18. Based upon the Findings of Fact set forth above, Respondent operated the Facility in violation of Sections 301 and 402 of the Act.
- 19. EPA has jurisdiction over the subject ma ter of this action, pursuant to Section 309 of the Act, 33 U.S.C. § 1319, and over the Respondent.

### IV. <u>CONSENT AGREEMENT</u>

- 20. Paragraphs 1 through 19, above, are re-a leged and incorporated herein by reference.
- 21. EPA and Respondent agree that it is in the public interest to resolve the issues alleged in this Consent Agreement without further itigation and the expense and effort that litigation entails.
- 22. Based upon the foregoing and pursuant t) Section 309(g) of the Act, 33 U.S.C. § 1319(g), and the CROP, it is hereby agreed by and between EPA and Respondent, and Respondent voluntarily and knowingly agrees as follows:

#### V. <u>TERMS OF SETTLEMENT</u>

- 23. For the purpose of this proceeding, Respondent:
  - a. Admits the jurisdictional allegations of this CA/FO;
  - b. Neither admits or denies the factual allegations contained herein;
  - c. Waives its right to contest the all gations, at a judicial or administrative hearing, or to appeal this CA/FO;

## VI. <u>PAYMENT OF CIVIL PENALTY</u>

- 24. Respondent shall pay a civil penalty in the amount of *Two thousand dollars (\$2,000.00)* to the "Treasurer of the United States of America."
- 25. Payments can be made by debit/credit card, check, or electronically. Electronic payments fall into two categories: wires and Auton ated Clearinghouse (ACH). Wires are same day and more costly. ACH is the next day or any future scheduled day and is less expensive. Please note that wires and ACH payments must be conducted through the sender's bank. - 26. Failure to pay the penalty in full according to the above provisions will result in referral of this matter to the United States Department of Justice or the United States Department of the Treasury for Collection.
- 27. Further, if the payment is not received or or before the due date, interest will be assessed at the annual rate established by the Secr stary of Treasury pursuant to the Debt Collection Act, 31 U.S.C. § 3717, on the overdue at nount from the due date through the date of

In addition, a late payment han lling charge of \$15.00 will be assessed for each 30-day period (or any portion thereof) following the due date in which the balance remains unpaid. A 6% per annum penalty also will be applied on any principal amount not paid within 90 days of the due date.

28. In addition, pursuant to Section 309(g)(9) of the Act, 33 U.S.C. § 1319(g)(9), if payment is not received by the due date, a quarterly nonpayment penalty will be imposed for each calendar quarter during which such nonpayment persists. The quarterly nonpayment penalty is 20% of the aggregate amount of penalties and quarterly nonpayment penalties, which are unpaid as of the beginning of such quarter. You also may be required to pay attorneys fees and costs for collection proceedings in connection with nonpayment.

29. The penalty to be paid is a civil penalty assessed by the EPA and shall not be deductible from Respondent's federal or New York State taxes.

## VII. GENERAL PROVISIONS

- 30. The provisions of this CA/FO shall be binding upon Respondent, its officers, directors, agents, servants, authorized representatives and successors or assigns, including but not limited to, subsequent purchasers. No transfer of ownership or operation shall relieve Respondent of its obligation to comply with this CA/FO.
- 31. The Respondent waives any right it may have pursuant to 40 C.F.R. § 22.8 to be present during discussions with or to be served with and to reply to any memorandum or communication addressed to the Director or the Regional Administrator where the purpose of such discussion, memorandum, or communication is to discuss a proposed settlement of this matter or to recommend that such official accept this Consent Agreement and issue the accompanying l'inal Order.
- 32. Except for the specific violations alleged herein, nothing in this agreement shall be construed as prohibiting, altering or in at y way limiting the ability of EPA to seek any other remedies or sanctions available by virtue of Respondent's violation of this agreement or of the statutes and regulations upon which this agreement is based, or for Respondent's violation of any applicable provision of law.
- 33. This CA/FO shall not relieve Respondent of its obligation to comply with all applicable provisions of federal, state or local law, nor shall it be construed to be a ruling on, or determination of, any issue related to any federal, state or local permit.
- 34. This CA/FO constitutes a settlement by EPA of all claims for civil penalties pursuant to the CWA for the violations by the Respondent alleged herein. Nothing in this CA/FO is intended to nor shall be construed to operate in any way to resolve any criminal liability of the Respondent. Compliance with this CA/FO shall not be a defense to any actions

- 35. Each undersigned representative of the parties to this Consent Agreement certifies that he or she is fully authorized by the party represented to enter into the terms and conditions of this Consent Agreement and to execute and legally bind that party to it.
- 36. Each party shall bear its own costs and attorney's fees in connection with the action resolved by this CA/FO.
