ORDER SCHEDULING STATUS TELECONFERENCE

By *Status Report and Motion Requesting Additional Time to Answer Complaint and to Submit an Executed Consent Agreement and Final Order* dated March 20, 2014, Attorney for Respondent stated that the parties had reached “an agreement in principle dispositive of all matters asserted in the Administrative Complaint”. Attorney for Respondent, with the concurrence of Complainant, requested that the Undersigned provide the parties with a ninety (90) day stay to finalize, execute and file the Consent Agreement and Final Order (CA/FO). The undersigned issued a stay through June 20, 2014 by order dated March 25, 2014.

On March 26, 2014, the Respondent filed an *Answer to the Administrative Complaint*, responding to the allegations set forth in the Complaint, and requesting a hearing. However, no mention was made of the stay or the CA/FO which was mentioned in Respondent’s earlier motion. The Undersigned believes it is in the interest of all parties to schedule a status teleconference to follow up on the progress of the parties in settling this matter.


In addition, the Undersigned notes the filing of a *Notice of Appearance of Additional Counsel for Complainant* dated March 26, 2014. By this Notice, Complainant, with the concurrence of Respondent, requests that the Undersigned take notice of the appearance of Evelyn Rivera-Ocasio as co-counsel to the attorney of record for the Complainant, Héctor L. Vélez Cruz.

In light of the considerations set forth herein, the Undersigned issues the following **ORDER**.


