## **ORDER SETTING EXPEDITED BRIEFING SCHEDULE**

Pursuant to this Tribunal's Orders of November 5, 2013, and August 10, 2015, the parties have filed their prehearing exchanges in this matter. They have also supplemented their prehearing exchanges by leave of this Tribunal. On March 25, 2016, Complainant filed another Motion for Leave to File Supplemental Prehearing Exchange ("Motion"), in which Complainant seeks leave to add one proposed witness, Respondent Adnan Kiriscioglu, and 13 proposed exhibits, a number of which purportedly contain confidential business information and/or personally identifiable information, to its prehearing exchange. Counsel for Respondents notified a staff attorney for this Tribunal on March 28, 2016, that Respondents received "the paper copy of Complainant's prehearing exchange" and will likely file an opposition to the Motion.

This proceeding is governed by the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits ("Rules of Practice"), set forth at 40 C.F.R. Part 22. The Rules of Practice establish a timetable for motion practice by directing parties to file any response to a written motion within 15 days after service of such motion and to file any reply to a written response within 10 days after service of such response. 40 C.F.R. § 22.16(b). The Rules of Practice further provide that the Presiding Officer "may set a shorter or longer time for response or reply, or make other orders concerning the disposition of motions." *Id.* Additionally, the Rules of Practice authorize the Presiding Officer to "take all measures necessary for the . . . efficient, fair and impartial adjudication of issues." 40 C.F.R. § 22.4(c) and (c)(10).

The hearing in this matter is scheduled to commence on April 25, 2016. Based upon the

timetable for motion practice established by the Rules of Practice, the instant Motion conceivably would not be fully briefed until shortly before the hearing is scheduled to begin, which would leave insufficient time for this Tribunal to consider the parties' arguments and issue a ruling and for the parties to prepare for the hearing accordingly. Because of these time constraints, and pursuant to the authority imparted to this Tribunal by the Rules of Practice, I hereby establish the following expedited briefing schedule for the Motion:<sup>1</sup>

Complainant's reply to Respondents' response April 11, 2016
