

ORDER OF REDESIGNATION

Administrative Law Judge Barbara A. Gunning is hereby redesignated as the Neutral Administrative Law Judge to conduct the Alternative Dispute Resolution (ADR) process in this case.

The ADR process will be conducted pursuant to the Dispute Resolution Act of 1990, 5 U.S.C. §§ 571-583, and pursuant to the procedures set forth in the Order of November 28, 2011 appointing Judge Spencer T. Nissen, except for the termination date. The ADR process under Judge Gunning will terminate February 29, 2012, unless terminated earlier by order of the undersigned at the request of either party or upon recommendation of Judge Gunning.


