PRELIMINARY STATEMENT

The above named Respondents make the following sir-rebuttal in response to the Complainant's rebuttal dated January 5, 2012.

As set forth below, the Respondents assert that Section 3512 of the Paperwork Reduction Act applies in the above captioned action and, as such, is a bar to the Complainant seeking a penalty herein.

RESPONDENTS' SIR-REBUTTAL ARGUMENT

There is no "Subsection 3518(c)(2)(B)(ii) of the PRA" as set forth in the Complainant's Rebuttal Argument. Section 3518(c)(2) states in relevant part: "This subchapter [44 USCS Section 3501 et seq.] applies to the collection of information during the conduct of general investigations...undertaken with reference to a category of individuals or entities such as a class of licensees or an entire industry.

Under Section 3518(c)(1)(B)(ii), the PRA does not apply to "an administrative action or investigation involving an agency against specific individuals or entities." The Request for Information, as set forth in the Complainant's Exhibits 17 through 23 attached to Complainant's Prehearing Exchange dated November 23, 2011, were the basis of the administrative complaint against the Respondents. The Respondents assert that none of the aforesaid Requests for Information indicated that these documents were being served upon the Respondents as part of an administrative action or a formal investigation. As such, the EPA should have obtained a

valid control number for the aforesaid Requests for Information. Therefore, the Respondents

assert that the protections set forth in Section 3512 of the PRA are applicable in this action.

Based upon the foregoing circumstances, the Respondents respectfully assert that the Paperwork Reduction Act applies to this action and as such, is a bar to the EPA seeking a penalty against the Respondent.
