## ORDER GRANTING ADDITIONAL TEMPORARY STAY OF PROCEEDINGS

On December 27, 2004, the Town of Scituate and the Scituate Wastewater Treatment

Plant ("Petitioners") filed a Petition for Review with the Environmental Appeals Board in the
above-captioned matter. In a Joint Status Report of Parties Regarding Potential Settlement

("Joint Report") filed April 13, 2005, U.S. EPA Region I ("Region") and Petitioners report on
their ongoing settlement discussions. The Region and Petitioners relate that they have not yet
reached a settlement but "are making progress toward settlement." In the Joint Report, the
parties also request an additional stay of proceedings, through May 31, 2005, in order to facilitate
their anticipated settlement.

For good cause shown, the Board hereby stays its consideration of this matter until May 31, 2005. No later than this date, the parties must file another joint status report with the Board, indicating whether settlement has been reached or whether the parties are continuing to make

progress toward settlement. If the parties believe, at this point, that additional time for settlement discussions is warranted, in addition to the joint status report mentioned above, the parties may file, no later than May 31, 2005, a request for additional stay of the Board's consideration of the Petition for Review. If at any time following the issuance of today's Order, the parties reach settlement in this matter, or if settlement discussions are terminated, the parties shall notify the Board promptly and recommend appropriate further action on these proceedings.
