SECOND ORDER STAYING PROCEEDINGS TO ALLOW PARTIES TO PARTICIPATE IN THE BOARD'S ALTERNATIVE DISPUTE RESOLUTION PROGRAM

On November 14, 2023, the parties in the above-captioned matter, U.S. Department of the Air Force and U.S. Environmental Protection Agency Region 10, (collectively, the "Parties") filed an "Agreement to Participate in ADR" with the Environmental Appeals Board ("Board"). In light of this agreement, on November 20, 2023, the Board issued an order staying all proceedings until February 5, 2024, to allow the Parties to participate in the Board's Alternative Dispute Resolution ("ADR") program.

The settlement judge has notified the panel that, considering the Parties' schedules, an additional 11-day extension of the stay beyond the expiration of the current stay, February 5, 2024, is warranted to accommodate the scheduling of an in-person ADR session. Accordingly, all proceedings in this matter are stayed until **Friday**, **February 16, 2024**.
