**ORDER GRANTING UNOPPOSED MOTION FOR EXTENSION OF TIME
TO FILE REPLY**


Center for Food Safety, Recirculating Farms Coalition, Tampa Bay Waterkeeper, Suncoast Waterkeeper, Healthy Gulf, Sierra Club, and Food & Water Watch (“Petitioners”) filed a petition for review challenging a National Pollutant Discharge Elimination System Permit issued to Ocean Era, Inc. U.S. Environmental Protection Agency Region 4 filed its response to the petition on August 15, 2025. Petitioners have filed an unopposed motion requesting a ten-day extension of time (to September 12, 2025) to file their reply brief. Unopposed Motion for Extension of Time to File Reply, at 1-2 (Aug. 20, 2025).
