ORDER GRANTING REQUEST FOR EXTENSION OF TIME TO FILE RESPONSE TO PETITIONS FOR REVIEW

On January 7, 2013, U.S. EPA Region 9 ("Region") filed a motion with the Environmental Appeals Board ("Board") requesting an extension of time to file a response to the three petitions of review filed in the above-captioned matter. The Region currently has until January 21, 2013, to file a response. *See* Letter from Eurika Durr, Clerk of the Board, to Nancy J. Marvel, Regional Counsel U.S. EPA Region 9, *Pio Pico Energy Center* (Dec. 31, 2012). The Region requests that the time for filing a response be extended until February 6, 2013.

In its motion, the Region explains that the substantial number of issues raised in the petitions, the need for consultation and coordination with EPA Headquarters, previously scheduled commitments of the two attorneys assigned to this matter, including international travel of the primary EPA Office of General Counsel attorney, will make it difficult to file a

¹ On December 19, 2012, Helping Hand Tools, Mr. Robert Simpson, and Sierra Club each filed a petition seeking review of the above-captioned prevention of significant deterioration ("PSD") permit. The permit authorizes Pio Pico Energy Center, LLC to construct and operate a 300 megawatt natural gasfired power plant in Otay Mesa, California. The Petitions challenge the Region's issuance, as well as several conditions, of the permit.

response on January 21. The Region represents that it contacted all three petitioners, as well as permittee, Pio Pico Energy Center, LLC, and none object to the request for an extension of time until February 6, 2013.

For good cause shown, the Board GRANTS the Region's request for an extension of time for filing a response to the three petitions filed in this case. The Region's response is now due on or before **February 6, 2013**. The Board similarly extends permittee's deadline for filing a response to the petitions. The Board, however, instructs the Region to file the certified index of the entire administrative record on or before **January 21, 2013**.
