SEVENTH ORDER EXTENDING STAY OF PROCEEDINGS TO ALLOW PARTIES TO PARTICIPATE IN THE BOARD'S ALTERNATIVE DISPUTE RESOLUTION PROGRAM

The Massachusetts Port Authority ("Massport") petitioned the Environmental Appeals
Board to review certain conditions of National Pollutant Discharge Elimination System permit
no. MA0000787, which the U.S. Environmental Protection Agency Region 1 issued to Massport.
EPA Region 1 and Massport agreed to participate in the Board's Alternative Dispute Resolution
("ADR") program. The Board issued an order staying all proceedings to allow for the ADR
process to proceed and subsequently extended the stay through November 7, 2024.

The settlement judge has notified the panel that a further extension of the stay in this proceeding beyond the expiration of the current stay on November 7, 2024 is warranted because the parties are making substantial progress towards resolution of this matter. Accordingly, all proceedings in this matter are stayed until **Friday**, **December 13, 2024**.
