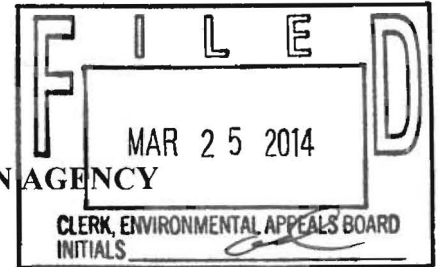

ORDER SCHEDULING STATUS CONFERENCE

On March 17, 2014, Jeff Brooks, Andrea Celestine, William Dearstyne, and Linda Haley, four individuals represented by the same counsel, jointly filed an amended petition for review requesting that the Environmental Appeals Board (“Board”) review a Clean Air Act Prevention of Significant Deterioration (“PSD”) permit that the Massachusetts Department of Environmental Protection (“DEP”) issued to Footprint Power Salem Harbor Development, LP (“Footprint”), on January 30, 2014. The PSD permit authorizes Footprint to construct a 692-megawatt combined cycle electric generating facility in Salem, Massachusetts. The Board previously issued an order granting Petitioners two additional weeks to file an amended petition for review. *See* Order Granting Extension for Time to File Petition for Review (Mar. 6, 2014). Pursuant to the Board’s order, DEP’s response and any response Footprint may choose to submit must be filed no later than Monday, April 7, 2014. *See id.* at 5.

After reviewing the amended petition for review and supporting exhibits, and in light of the time-sensitive nature of this appeal, the Board has determined that a status conference would be beneficial at this juncture. Accordingly, counsel for Petitioners, DEP, and Footprint are hereby ordered to participate in a status conference. The Board also invites counsel from

Region 1 or from EPA's Office of General Counsel, as appropriate, to participate in the status conference.

The status conference will be held on Tuesday, April 1, 2014, beginning at 2:00 p.m. EDT in the Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building, Room 1152, 1201 Constitution Avenue, Washington, DC 20005. Parties who wish to attend the status conference in person or to participate via videoconference equipment should contact the Clerk of the Board, Eurika Durr, at (202) 233-0122, no later than Friday, March 28, 2014. Parties who cannot attend in person or via videoconference may participate via telephone, and should contact the Clerk of the Board for further instruction no later than Friday, March 28, 2014.
