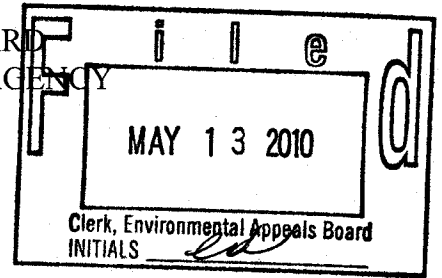

**AMENDED ORDER GRANTING MOTION TO RESCHEDULE ORAL ARGUMENT**

On April 9, 2010, the Board scheduled oral argument in the matter of Smith Farm Enterprises, LLC ("Smith Farm"), CWA Appeal No. 08-02, for May 20th, 2010. On May 3, 2010, Appellee (U.S. EPA, Region 3) moved to reschedule oral argument based on a newly developed conflict in the assigned counsel's schedule and a consequent concern regarding counsel's ability to adequately prepare for oral argument. Appellant Smith Farm joined in the motion citing its counsel's own schedule conflicts.

Upon consideration, the Board has decided to **GRANT** the Region's motion to reschedule oral argument in this matter. The Board will now hear oral argument on July 20, 2010, at 10:00 a.m., in the Administrative Courtroom, U.S. Environmental Protection Agency, EPA East Building, Room 1152, 1201 Constitution Avenue, N.W., Washington, D.C. Oral argument shall proceed as follows: (1) thirty minutes for Appellant Smith Farm; (2) thirty minutes for Appellee Region 3. At the outset of the proceedings, Smith Farm may reserve up to five minutes of their allocated time for rebuttal.


