**ORDER SCHEDULING ORAL ARGUMENT**

The American Bottom Conservancy (“Conservancy”) has filed with the Environmental Appeals Board (“Board”) a petition challenging a permit issued by Region 5 of the U.S. Environmental Protection Agency (“Region 5”) to Veolia ES Technical Solutions, LLC (“Veolia”) under subchapter V of the Clean Air Act, 42 U.S.C. §§ 7661-7661f, and part 71 of title 40 of the Code of Federal Regulations.

Upon review of the record and the parties’ submissions, the Board has determined that oral argument will assist the Board in its deliberations. Accordingly, the Board requests that the parties present oral argument on **Thursday, March 5, 2020**, beginning at **10:30 AM Eastern Time** in the Administrative Courtroom (Room 1152), U.S. Environmental Protection Agency, William Jefferson Clinton East Building, 1201 Constitution Avenue, NW, Washington, D.C 20004. The Board has allocated a total of sixty minutes for oral argument, with argument to proceed as follows:


- The Conservancy: 30 minutes
- Region 5: 20 minutes
- Veolia: 10 minutes
- The Conservancy may reserve up to 10 minutes of its thirty-minute allocation for rebuttal.

Counsel, or other duly authorized representatives of the parties, may opt to present argument by videoconference.<sup>1</sup> The Board directs each party to file a “Notice Regarding Oral Argument” by **February 4, 2020**, providing the name of the individual who will present argument on its behalf and indicating whether that individual will appear in person or request to appear by videoconference.<sup>2</sup>
