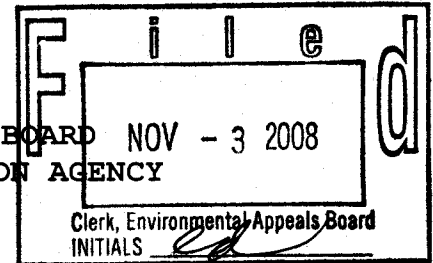

ORDER SCHEDULING TELECONFERENCE

On September 25, 2008, the parties in the above-captioned matter, U.S. EPA Region 5 (the "Region") and PPG Industries Ohio, Inc. and PPG Industries, Inc. (collectively "PPG"), filed a joint status report explaining the status of the permit modification process and their expectations for resolution of these proceedings. In their report, the parties explain that a public meeting on the proposed changes to the permit has been scheduled for November 3, 2008, with the public comment period scheduled to close on November 22, 2008. In addition, the parties represent that they anticipate final permit modification and withdrawal of the appeal by the end of November or early December 2008. The parties proposed to file a joint status report on or before November 5, 2008, to confirm that the public meeting had occurred.

The Board does not think that the November 5 joint report is necessary. Instead, the Board will hold a teleconference, on November 25, 2008, for a progress report.

Accordingly, the parties are hereby requested to participate in a conference beginning at 11:00 a.m. EST on Tuesday, November 25, 2008. The participants should notify the Clerk of the Board of a contact phone number by no later than Thursday, November 20, 2008. The Clerk of the Board can be reached at (202) 233-0122. The Clerk of the Board will initiate the conference call.
