ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE CERTIFIED ADMINISTRATIVE RECORD AND RESPONSE

By motion dated February 14, 2011, the State of Illinois requests an extension of time to file the certified administrative record and response to the petition for review filed by the Sierra Club in the above-captioned matter. Motion for Extension of Time to File Certified Index of the Administrative Record and Response (Feb. 14, 2011) ("Motion"). A letter from the Clerk of the Environmental Appeals Board ("Board") to the Illinois Environmental Protection Agency, which issued the above-captioned permit, requested a response seeking summary disposition by no later than February 14, 2011, or if a response seeking summary disposition is not filed, a response to the merits of the petition by March 15, 2011.

In the Motion, Illinois requests an extension until April 15, 2011. Motion at 1. Illinois states that the matter was received in the Office of the Illinois Attorney General on February 8, 2011, and that the permitting agency continues to prepare the certified index of the administrative record. *Id.* According to Illinois, "[i]n light of these circumstances and the technical issues raised by the Petition, Illinois will not be able to meet the Board's March 15, 2011, deadline for filing a Response to the Petition." *Id.* Finally, Illinois represents that Sierra Club does not oppose the Motion. *Id.* at 1-2.

In light of these representations, the Motion is granted. The certified administrative index and response to the petition for review must now be filed with the Board no later than **April 15, 2011**.¹
