**ORDER GRANTING JOINT MOTION FOR ABEYANCE
AND CANCELLING ORAL ARGUMENT**

In an Order dated October 3, 2024, the Environmental Appeals Board scheduled oral argument in this matter for November 21, 2024. On November 13, 2024, Petitioner Harvest Four Corners, LLC and Respondent U.S. Environmental Protection Agency Region 6 filed a Joint Motion for Abeyance. According to the Motion, the parties initiated settlement discussions on November 12, 2024, and request that the case be held in abeyance and oral argument be postponed pending settlement discussions.

Based upon the representations of the parties and in accordance with 40 C.F.R. § 124.19(n), the Board hereby **GRANTS** the Motion and holds the case in abeyance. The oral argument scheduled for November 21, 2024 is cancelled.
