SCHEDULING ORDER ON MOTION FOR RECONSIDERATION

On September 20, 2024, the Ute Indian Tribe of the Uintah and Ouray Reservation filed a Motion for Reconsideration of the Environmental Appeals Board's September 10, 2024, Order Denying Review in this matter. In that Order, the Board denied review of the Tribe's petition challenging EPA Region 8's renewal of a Clean Air Act Title V permit issued to Deseret Generation and Transmission Co-operative for the Bonanza Power Plant. The Motion for Reconsideration states that the Board's Order Denying Review was clearly erroneous in four areas. *See* Motion for Reconsideration 5-11 (Sept. 20, 2024). Motions for Reconsideration are addressed in 40 C.F.R § 124.19(m). The Board's regulations provide for responses to motions. *See* 40 C.F.R. § 124.19(f)(3). The Board hereby issues this Scheduling Order requesting a response from the Region and clarifying deadlines for responses and replies. *See* 40 C.F.R. § 124.19(n).

The Region must file a response to the Motion for Reconsideration no later than Monday, October 7, 2024. *See id.* § 124.19(f)(3). Deseret may file a response, and that response is also due no later than October 7, 2024. The response(s) may not address any issue other than the specific issues raised in the Motion for Reconsideration. The Tribe may file a reply to the response(s) no later than October 17, 2024. *See id.* § 124.19(f)(4). The reply "must not introduce any new issues or arguments and may respond only to matters presented in the response." *Id.* The response(s) and reply shall comply with the limitations in 40 C.F.R. § 124.19(f)(5).
