1. Petitioners filed their Petition for Review on February 22, 2024.
2. Permittee filed its Response to Petition for Review on April 22, 2024.
3. EPA previously moved for and received extensions to its response deadline and will file its response on May 10, 2024. Petitioners’ reply to EPA will be due on May 24, 2024.
