MASSACHUSETTS AUDUBON SOCIETY'S NOTICE OF STATUS AS INTERESTED PARTY

On October 24, 2016 the United States Environmental Protection Agency, Region 1

("USEPA"), issued a Final Modification of RCRA Corrective Action Permit ("Final Permit") for the GE-Pittsfield/Housatonic River Site, "Rest of River" ("the River") requiring General Electric ("GE") to remediate contamination it caused to the River, its property and abutting Massachusetts Audubon Society ("Mass Audubon") property. Pursuant to 40 C.F.R. §124.19(a)(4), anyone seeking a petition for review of an agency decision, including USEPA Final Permits under the Resource Conservation and Recovery Act ("RCRA") must file an appeal within 30 days of its issuance. The appeal must identify contested permit conditions and other specific challenges to the permit decision. Petitioners must meet certain minimum threshold requirements, including that they participated in the comment period and thus have standing to seek review, that issues raised were raised in comment period and that the Petitioner identify the specific comment and response that warrants review. Mass Audubon participated in the public comment period and was among the recipients of the Final Permit on October 24, 2016. (Attached hereto as Exhibit A is a true copy of the October 24, 2016, Electronic Mail notice of

said Final Permit Modification.) Mass Audubon has been closely engaged in the planning process for the cleanup of polychlorinated biphenyls ("PCBs") from the River for many years as a landowner directly affected by GE's PCB contamination that is the subject of the Final Permit.

Mass Audubon does not wish to appeal the Final Permit; however, Mass Audubon is aware that at least two other parties intend to appeal. In the event that appeals are filed, Mass Audubon has a vested interest in the proceedings given the location of Mass Audubon-owned property along the River. In conducting work under the Final Permit, GE will conduct work directly on Mass Audubon property. In addition, the remedial work on GE property and River property will have impacts on Mass Audubon property. GE will need to work with Mass Audubon to obtain easements and related agreements in order to enter Mass Audubon land and to conduct work affecting its land. Mass Audubon is a party aggrieved by the actions of GE and will continue to be affected by the corrective actions required by USEPA's Final Permit. 40 CFR 21.30 provides that the EAB "shall adopt, modify, or set aside the findings of fact and conclusions of law or discretion" contained in the decision being reviewed (if EAB even accepts the request for review). EAB will give discretion to the particularized knowledge of the agency that issued the decision. See, e.g., In re Chempace Corp., 9 E.A.D. 119, 134 (EAB 2000).

If a decision is reached which overturns the Final Permit or remands it to the Regional Administrator for further review Mass Audubon may be aggrieved and would at such time want to file a further appeal to federal court. Notwithstanding Mass Audubon's belief that it would have standing to sue in federal court even if it did not participate in the EAB review (for which the only way to participate is to appeal or intervene in contesting the Final Permit, which Mass Audubon has no basis to do), in order to further preserve its rights to federal judicial review, Mass Audubon requests that it be recognized as an interested party in these proceedings.

The Permittee is required to conduct certain activities at areas affected by releases of hazardous waste and/or hazardous constituents from the General Electric Facility located in Pittsfield, Massachusetts, in accordance with Sections 3004(u), 3004(v), and 3005(c) of the Resource Conservation and Recovery Act (RCRA), as amended by the Hazardous and Solid Waste Amendments of 1984 (HSWA), as specified in the conditions set forth herein.

This Permit has been prepared for RCRA Corrective Action activities to be performed by General Electric pursuant to a final Consent Decree, <u>United States</u>, et al. v. General Electric Company (D. Mass.) ("Consent Decree"). The Consent Decree memorializes an agreement to address releases of Waste Materials, including hazardous substances, hazardous waste, and/or hazardous constituents from the General Electric Company's Facility in Pittsfield, Massachusetts, including, but not limited to, the releases of hazardous waste and/or hazardous constituents addressed in this Permit. This Permit, upon the Effective Date, shall replace the HSWA Permit previously issued to the Permittee, initially issued on February 8, 1991, modified effective January 3, 1994, reissued in October 2000 and reissued again, effective December 5, 2007. Upon the Effective Date of this Reissued Permit, the previously issued 2007 Permit hereby is revoked, and, pursuant to the Consent Decree, the Remedial Action set forth in the Permit shall be implemented pursuant to Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) and the Consent Decree.
