JOINT MOTION FOR DISMISSAL AND STATUS REPORT

Permittee Harvest Four Corners, LLC ("Harvest") and Region 6 of the United States

Environmental Protection Agency ("USEPA") (the "Parties"), by and through their undersigned

attorneys, respectfully move the Environmental Appeals Board ("EAB" or the "Board") to dismiss

the Petition for Review as moot given USEPA's final action to reopen and revise the Title V permit

to remove the contested permit conditions that are the subject of this appeal. In support of their

motion for dismissal, the parties state the following:

- 1. On July 29, 2024, Harvest filed a Petition for Review appealing USEPA's final Title V renewal permit for the Los Mestenios Compressor Station ("Facility"), which USEPA issued on June 28, 2024. Oral argument was scheduled for November 21, 2024.
- 2. On November 13, 2024, the Parties requested that the appeal be held in abeyance and oral argument be postponed while the Parties continued settlement discussions related to the final Title V renewal permit for the Facility. On November 15, 2024, the Board issued the Order Granting Joint Motion for Abeyance and Cancelling Oral Argument. Since that time, the Board has granted several extensions to the abeyance while the Parties continued settlement discussions.
- 3. Pursuant to these settlement discussions, USEPA agreed to reopen and revise the Title V renewal permit to remove the contested provisions utilizing its authority under 40 C.F.R. § 71.7(f).

On August 4, 2025, USEPA notified Harvest of its intent to reopen the Title V renewal permit. On September 4, 2025, USEPA issued public notice requesting public comment on the draft *reopened for cause* Title V renewal permit for the Facility. There were no requests for public hearing and no written comments received during the public comment period. On October 20, 2025, USEPA made a final decision in accordance with 40 C.F.R. § 71.7 and 40 C.F.R. § 124 to issue the final Title V renewal permit to Harvest for the Facility. Since no comments were received on the reopened for cause permit during the public comment period, the final Title V permit for the Facility became effective immediately upon issuance. *See* 40 C.F.R. § 71.11(i)(2)(iii).

4. Because the USEPA revised and issued the Title V renewal permit to remove the contested provisions that were the subject of this appeal, the matter is now moot and the Parties move to dismiss the Petition for Review.

WHEREFORE, the Parties respectfully request the EAB grant this Motion and dismiss the Petition for Review.
