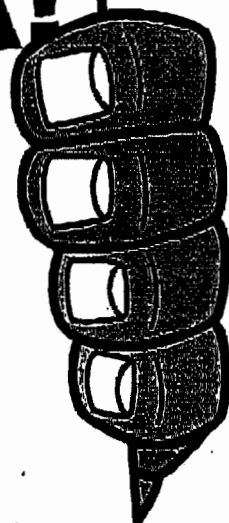

- ① THE PETITIONER OF UIC PERMIT NO 14-67 WAS REQUESTING A MAY 12, 2014 FILING DATE ONLY - AS MY MAY 22, 2014 MOTION SPECIFIED - ALL THROUGHOUT!
- ② THE REGION'S RESPONSE PER JOHN P. STERETT WAS INHERENTLY DISHONEST IS DECEPTFUL IN THAT TRACKING INFO WAS NOT INCLUDED AT ALL IN THE REGION'S EXAM OF WHAT WENT WRONG WITH MY 2-DAY GUARANTEED USPS EXPRESS MAIL FILING THAT TOOK 4 DAYS - USING EXPRESS MAIL ADDRESS ON USEPA REG 5 CERTIFIED LETTER NO 7011 1150 0000 2642 5302!
- ③ PETITIONER RECENTLY WENT TO UNITED STATES POST OFFICE, BROOKLYN, ME 49230 AND TALKED WITH POSTMASTER LAURIE MCDOWELL WHO CALLED TIM ECKINS (USEPA'S PERMIT WRITER) 312-886-0263, AND TIM ECKINS STATED (INIL) THAT (GERMAN'S) EXPRESS MAIL WAS FORWARDED FROM THE EXPRESS MAIL ADDRESS BECAUSE "THE EXPRESS MAIL ADDRESS WAS FOR FEDER..." THEREFORE, RIGHT NOW, THE USEPA REGION 5'S CERTIFIED LETTER NO 7011 1150 0000 2642 5302 IS NOW ON FILE AT THE (COA) UNITED STATES POST OFFICE, BROOKLYN, ME AS HAVING AN INCORRECT USPS EXPRESS MAIL ADDRESS; ATTACHED TO POSTAL FORM PS 3533 AND TRACKING INFO (THE POSTMASTER WAS CERTAINLY INTERESTED IN) AS REASON FOR MY REFUND OF 19.99 ON JUNE 3, 2014!
