Dear Ms. Durr:

At the recent oral argument in the above-referenced matter, the Board asked me about the number of NPDES permits that the Region has issued to POTWs that impose requirements on municipal satellite collection systems similar to the co-permittee provisions of the Upper Blackstone permit. I indicated that I did not know, but would provide a response in a letter.

The Region has identified 25 permits issued by the Region to POTWs in New Hampshire and Massachusetts (in addition to the permit issued to Upper Blackstone) since September 2000 that include municipal satellite collection systems as co-permittees. The 25 permits include a total of 55 satellite collection systems as co-permittees. The Region has only named owners of municipal collection systems as co-permittees. A list of the permits is appended and most of the permits are available on Region 1's website.

I would appreciate if you would provide this response to the panel. Please let me know if you have any questions.
