STATUS REPORT


By joint motion filed on July 29, 2005, Brook Village Associates Limited Partnership ("Brook Village") and the United States Environmental Protection Agency, Region 1 ("Region") requested a stay of the proceedings in this Comprehensive Environmental Response, Compensation and Liability Act ("CERCLA") reimbursement matter under 42 U.S.C. § 9606(b). On August 4, 2005, the Environmental Appeals Board ("Board") issued an order ("Order") granting the stay pending the decision of the United States District Court for the District of Rhode Island ("Court") to approve or disapprove the proposed Consent Decree which was lodged with the Court on May 6, 2005. Pursuant to the Order, the parties are required to jointly notify the Board within ten days of the Court's approval or disapproval of the proposed Consent Decree.

A hearing on the Region's Motion to Enter the proposed Consent Decree was scheduled before Judge William Smith on July 17, 2006. However, that hearing was not held because Judge Smith recused himself from this matter and transferred it to Judge Mary Lisi. A hearing on the merits of the Region's Motion to Enter was held before Judge Lisi on September 18, 2006. The parties are awaiting Judge Lisi's decision to approve or disapprove

the proposed Consent Decree. As required by the Order, the parties will notify the Board within ten days of receiving Judge Lisi's decision and will include in that notice a discussion of whether the stay should be continued; the petition should be dismissed; or a future schedule should be established.
