Please file an original (signed in blue ink) and five copies of these materials no later than August 11, 2008, and send a copy of the response and the certified index to the petitioner with a certificate of service showing the date and method of service.

The envelope or packaging must also clearly state the case name and appeal number in the lower left hand corner.
