RE: Massachusetts Port Authority NPDES Permit No. MA 0000787; NPDES Appeal No. 23-03

Dear Mr. Cortes and Ms. Burdi:

In accordance with 40 C.F.R. §§ 124.16 and 124.60, the U.S. Environmental Protection Agency ("EPA") Region 1 ("the Region") is providing notice of uncontested and severable permit conditions in connection with National Pollutant Discharge Elimination System ("NPDES") Permit No. MA 0000787, issued by the Region to the Massachusetts Port Authority ("Massport") on August 24, 2023 ("2023 Permit"). When effective, the 2023 Permit will supersede Massport's previous permit, which has been administratively-continued since its expiration in July 2012 ("2007 Permit").

On September 25, 2023, Massport timely filed a Petition for Review of the 2023 Permit. Massport stated that it was contesting "Part I.A.1 and Part I.A.2, only with respect to the numeric limits on fecal coliform and *Enterococcus*." *See* Petition at 11. Specifically, the contested Permit provisions are:

- 1. The fecal coliform numeric limit from Outfall 01A (Permit Part I.A.1, pg. 4); and
- 2. The *Enterrococcus* numeric limits from Outfalls 01Å, 02Å, 03Å, and 04Å (Permit Parts I.A.1 and I.A.2, pgs. 4, 11).

When a permit appeal is filed, EPA must issue a notification identifying which permit conditions are stayed as a result of the appeal and which permit conditions will go into effect. See 40 C.F.R. §§ 124.16(a)(2)(i) and (ii). While an appeal is pending, contested permit conditions are stayed. Id. at § 124.16(a)(1). Uncontested permit conditions that are "inseverable" from contested conditions are also considered to be contested and are stayed. Id. at §§ 124.60(b)(4), 124.16(a)(2)(i). Uncontested permit conditions that are severable from contested conditions are not stayed and become enforceable conditions of the permit. Id. at §§ 124.16(a)(2)(i) and (ii).

The Region is notifying you that the Contested Conditions are stayed pending final agency action. The stay operates in accordance with EPA regulations. As the holder of an existing, administratively-continued permit, Massport must continue to comply with conditions of that permit that correspond to the stayed conditions. *Id.* at § 124.16(c)(2). As such:

- 1. The fecal coliform numeric limit for Outfall 01A in the 2023 Permit is stayed. There is no corresponding numeric limitation in the 2007 Permit, but the permittee must comply with the 2007 Permit's monthly grab sample and reporting requirements.
- 2. The *Enterococcus* numeric limits for Outfalls 01A, 02A, 03A, and 04A in the 2023 Permit are stayed. There are no corresponding numeric limitations in the 2007 Permit, but the permittee must comply with the 2007 Permit's monthly grab sample and reporting requirements.

EPA has determined that all other conditions of the 2023 Permit are uncontested and severable, and accordingly will become fully effective and enforceable on November 1, 2023.
