THIS CERTIFIED LETTER, DATED APR. 16, 2013, FOLLOWED A PREVIOUS CERTIFIED LETTER, FROM THE WATER DIVISION DIRECTOR - TINKA HYDE, DATED APR. 8, 2013, I RECEIVED ON MON. APR. 15, 2013, WHICH WAS HEADED BY:
"WITHDRAWAL OF PERMIT BY REGIONAL ADMINISTRATOR WEST BAY EXPLORATION COMPANY, JACKSON COUNTY MICHIGAN PERMIT NUMBER: MI-075-2D-0009.
