# NOTIFICATION OF CHANGE IN LAW

On December 23, 2011, the President signed into law the Consolidated Appropriations Act of 2012, Pub. L. No. 112-74. As the Board may be aware, the Act amended Section 328 of the CAA to divest the Environmental Protection Agency of the authority to issue air quality permits to Outer Continental Shelf ("OCS") sources located off the North Slope Borough of the State of Alaska. The relevant provision of this Act is excerpted and attached for the Board's reference.

The enacted legislation provides that the transfer of authority "shall not invalidate or stay -(1) any air quality permit pending or existing as of the date of the enactment of this Act; or (2) any proceeding related thereto." Under the present circumstances, Region 10 interprets this provision to mean that the Act does not affect or stay OCS Permit No. R10 OCS030000 or the above-captioned appeal proceedings, as this permit is a pending permit and the appeal proceedings are proceedings relating to such pending permit.

(e) WAIVER OF GRAZING PERMITS AND LEASES.—The Secretary of the Interior and the Secretary of Agriculture may accept the voluntary waiver of any valid existing lease or permit authorizing grazing on National Forest System land described in subsection (a) or public lands described in subsection (c). If the grazing permit or lease for a grazing allotment is only partially within the area of potential domestic sheep and bighorn sheep contact, the affected permitee may elect to waive only the portion of the grazing permit or lease that is within that area. #### FUNDING PROHIBITION

SEC. 433. None of the funds made available by this Act may SEC. 433. None of the funds made available by this Act may be used to enter into a contract, memorandum of understanding, or cooperative agreement with, make a grant to, or provide a loan or loan guarantee to, any corporation that was convicted (or had an officer or agent of such corporation acting on behalf of the corporation convicted) of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency is aware of the conviction, unless the agency has considered suspension or debarment of the corporation, or such officer or agent and made a determination that this further action is not necessary to protect the interests of the Government to protect the interests of the Government.

#### LIMITATION WITH RESPECT TO DELINQUENT TAX DEBTS

SEC. 434. None of the funds made available by this Act may be used to enter into a contract, memorandum of understanding, or cooperative agreement with, make a grant to, or provide a loan or loan guarantee to, any corporation with respect to which any unpaid Federal tax liability that has been assessed, for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant
