JOINT REQUEST FOR EXTENSION OF STAY

Now comes PPG Industries Ohio, Inc. and The United States Environmental Protection Agency, Region 5 to jointly request that the Board issue an Order continuing the stay of these proceedings to allow the parties to continue their settlement discussions. The Parties apologize to the Board for failing to file this request on or before April 4, 2008 as directed in the Board's last Order. The Region and PPG are continuing their settlement discussions. Although the two remaining issues are still unresolved, the Parties continue to believe that they are making progress toward settlement. As previously reported to the Board, on January 30, 2008, PPG provided a response to the Region on the two remaining outstanding issues. The Region provided a written response to the January 30, 2008 proposal on February 27, 2008. PPG responded with a specific proposal to resolve one of the remaining issues and a request for an interpretation on the other issue on March 10, 2008. The Region is now considering both the proposed language and the request for interpretation. Since productive settlement discussions are continuing, the parties believe that continuing the stay of these proceedings is warranted.

The parties have also initiated preliminary discussions on the procedural steps that will be required to modify the permit underlying this appeal to reflect any pending settlement. The parties will need additional time to consider the appropriate approach.

The parties therefore request that the Board issue an Order continuing the stay in these proceedings until June 13, 2008, at which time the parties will provide the Board with an update on the status of their negotiations with indication as to whether or not future proceedings are needed. Again the Parties apologize for the delay in filing this request.
