STATUS REPORT

On October 18, 2005, the Environmental Appeals Board issued a Consolidation Order and Order Granting Stay in the above-captioned matter. The Board’s order stayed further proceedings pending an anticipated settlement between the Environmental Protection Agency (“EPA”) and General Electric Company (“GE”) of this matter and related judicial cases involving the Grand Street Mercury Site. The Board directed the parties to file a status report by January 18, 2006, and 90 days thereafter.

EPA and GE have completed negotiations on a consent decree in the related judicial cases. The consent decree was lodged with the court on April 25, 2006, and on July 11, 2006, the United States Department of Justice moved on behalf of EPA for entry of the consent decree. Assuming that the court approves and enters the consent decree, GE will thereupon dismiss, with prejudice, this petition before the Board.

GE is authorized to state that EPA joins in this status report.
