FOURTH JOINT STATUS REPORT AND MOTION TO EXTEND STAY OF PROCEEDINGS

On January 30, 2020, Region 1 of the United States Environmental Protection
Agency ("Region") issued National Pollutant Discharge Elimination System Permit No.
MA0003557 ("NPDES Permit") to Holtec Decommissioning International, LLC
("HDI"), for the Pilgrim Nuclear Power Station in Plymouth, Massachusetts, authorizing
the intake of service water from, and the discharge of certain wastewaters and
stormwaters to, Cape Cod Bay. On March 6, 2020, HDI and Holtec Pilgrim, LLC
(collectively, "Holtec") and Entergy Nuclear Operations, Inc. ("Entergy" and together
with Holtec, "Petitioners") filed a Petition for Review ("Petition") with the
Environmental Appeals Board ("EAB" or "Board") of several conditions of the NPDES
Permit. The parties requested a stay of the proceedings to allow them to begin settlement
discussions, which the Board granted on March 31, 2020, ordering the parties to file joint
status reports at least every 45 days. *See* Order Granting Joint Motion to Stay
Proceedings (Mar. 31, 2020).

Since that time, three additional motions have been filed that impact the issues raised in the Petition, the parties to this action, and the current stay of the proceedings. In an order issued July 22, 2020, the Board granted Holtec's Motion for Partial Withdrawal of Petition for Review, Entergy's Motion for Withdrawal of Entergy as Petitioner (without prejudice), and the Region and Holtec's Joint Motion to Extend the Stay of the Proceedings. *See* Order Granting the Motion for Partial Withdrawal of Petition for Review, the Motion for Withdrawal of Entergy as Petitioner, and the Joint Motion to Stay the Proceedings (July 22, 2020). In the Order, the Board extended the stay to Thursday, October 22, 2020, and directed the parties to file status reports at least every forty-five days, with the first status report due by Tuesday, September 8, 2020. *Id.* The Board further ordered that any request to extend the stay further be filed with the Board by October 15, 2020. *Id.* Accordingly, Holtec and the Region file the following status report and motion to extend the stay of proceedings for an additional 30 days.

The Region and Holtec have continued to pursue negotiations to settle the appeal, including the further exchange of proposed revisions to the draft documents necessary for settlement and several follow-up telephone calls between counsel to discuss the outstanding issues. The parties have also met via video conference to review technical information relevant to these documents. While one essential document remains to be finalized, the Region and Holtec represent that they are very close to resolving the remaining issues and are optimistic that a negotiated resolution is possible, albeit with a brief extension of the stay to allow the Region and Holtec to reach agreement on a few important details and to allow time for the appropriate representatives to execute the documents. An extension would also provide time for appropriate coordination with the

Massachusetts Department of Environmental Protection. The Region and Holtec respectfully request, therefore, that the Board continue the stay for an additional 30 days.
