

## MOTION TO PARTICIPATE IN APPEAL

Sunoco Partners Marketing & Terminals, L.P. ("SPMT"), by its counsel Beveridge & Diamond P.C. and Miller Johnson, moves for authorization to participate in this proceeding and address all issues pertaining to the petition for review filed by counsel for Environmental Disposal Systems ("EDS") challenging the SPMT cavern expansion permit.

As permittee, SPMT has a strong interest in the defense of its permit. The permitted cavern expansion is integral to SPMT's business. SPMT therefore wishes to address the challenges to its permit by EDS, including any procedural aspect of the petition and the substance of the petition. SPMT can assist the Environmental Appeals Board in its review of this matter as SPMT is familiar with the permit and the business to which it pertains.

We understand that an extension has been granted to U.S. EPA, Region 5, for the submission of its papers on this appeal. The participation by SPMT will not complicate or delay the review of this appeal as SPMT is fully apprised of the facts concerning the underlying permit and can address issues raised by EDS's challenge promptly. SPMT is not aware whether the petition for review will be rejected or allowed to proceed. SPMT wishes to be heard why the petition does not merit review.

The practice and procedures of the Environmental Appeals Board provide for participation by a permittee in an appeal from or challenge to a permit by other parties like EDS. SPMT wishes to participate now and to provide comment on the petition by EDS.

SPMT respectfully requests the approval of this motion and a schedule for SPMT to comment on, and participate in the review of this challenge to, its permit.
