**NOTICE OF APPEARANCE OF LIMETREE BAY REFINING, LLC AND
LIMETREE BAY TERMINALS, LLC**

Pursuant to 40 C.F.R. § 124.19(b)(3), permit applicant Limetree Bay Refining, LLC and Limetree Bay Terminals, LLC (collectively, “Limetree”) hereby files its notice of appearance in this permit appeal process, CAA Appeal No. 20-02. This permit appeal was initiated on February 3, 2021 when St. Croix Environmental Association, Center for Biological Diversity, Sierra Club, and Elizabeth Neville filed a Petition for Review of Limetree’s Plantwide Applicability Limit (“PAL”) Permit issued by EPA Region 2, Permit No. EPA-PAL-VI-001/2019. Limetree files its notice of appearance by and through its undersigned counsel. Limetree will file a response to the petition for review on or before March 26, 2021, in accordance with two orders issued by the Environmental Appeals Board (“Board”). Order Granting Motion for Extension of Time to File Response (EAB Feb. 12, 2021) (extending the deadline for “the EPA Offices’ response to each petition for review (and other responsive filings required by 40 C.F.R. § 124.19(b))” to March 26, 2021); Order Clarifying February 12, 2021, Order Granting Motion for Extension of Time to File Response (EAB Feb. 16, 2021) (clarifying that the March 26, 2021 deadline “applies to Permittees Limetree Bay Terminals, L.L.C. and Limetree Bay Refining, L.L.C. should they choose to file a response to the petition in CAA Appeal No. 20-02.”).
