On July 20, 2023, the U.S. Environmental Protection Agency issued a Notice of Violation and a Compliance Order/Settlement Agreement (Settlement Agreement) for a violation of the Federal underground storage tank (UST) regulations at the Remington Oil Co. facility located at 601 Superior Street, Antigo, Wisconsin. The violation was identified during an EPA UST inspection conducted on June 27, 2023.

On August 10, 2023, EPA received your signed copy of the Settlement Agreement. On July 13, 2023, EPA received your supporting documentation that the violation has been corrected. Your payment of \$733.00 (check #067339) was confirmed by our finance office on August 17, 2023. The Settlement Agreement states that it is effective upon EPA's final approval. I have enclosed a signed and dated copy of the approved Settlement Agreement. The original Settlement Agreement will remain in EPA's file. We also have accepted and processed your payment as part of the settlement process.
